Sir,

In producing herewith two arrested accused persons namely 1) Kalu Paswan (28 yrs) S/O Lt. Ram Avtar Paswan of Prakashnagar W/No. 43 PS Bhaktinagar Dist. Jalpaiguri 2) Tapan Das (35 yrs) S/O Lt. Tarani Das of Midle plus Debidanga PS Pradhannagar Dist. Darjeeling along with following seized articles :-

- 1] One Truck bearing Registration No **WB-65/5517** loaded with illegal river bed sand and material seized from the possession of Tapan Das (35 yrs) S/O Lt. Tarani Das of Midle plus Debidanga PS Pradhannagar Dist. Darjeeling
- 2] One Truck bearing Registration **WB-76/2145** loaded with illegal river bed sand and material seized from the possession of 1) Kalu Paswan (28 yrs) S/O Lt. Ram Avtar Paswan of Prakashnagar W/No. 43 PS Bhaktinagar Dist. Jalpaiguri.

I, SI Ramanath Karjee of P.S Bhaktinagar, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted arrested accused persons along with the owner of Truck bearing Registration **WB-65/5517** and **WB-76/2145** and others to the effect that on 10.08.22 at about 07.15 hrs I along with force were performing K-37 Mobile van duty at Salugara Bazar area vide GDE No 476 Dated 10.08.22. I received source information that two Truck bearing Registration No **WB-65/5517** and **WB-76/2145** are being loading with illegal River Bed sand and Material at Bedgara River Ghat under Bhaktiagar PS without any valid documents. Accordingly, I shared the information with I/C Bhaktinagar P.S, SPC over telephone and as per his kind verbal direction as being indicated by the source, we apprehended two Trucks having No bearing Registration No **WB-65/5517** and **WB-76/2145** loaded river bed material illegally along with it's drivers. Seeing the activities of the driver, there was reason to believe that there was something illegal in the above noted trucks. Accordingly, I checked both the vehicle and found both the truck were loaded with illegal river bed sand on demand, both the driver of the Truck disclosed their name and identity as noted above. Further, on demand both the driver failed to produce their valid documents related to the Truck as well as the loaded River Bed sand materials, pebbles in their Truck. Hence there was reason to believe that the above noted both drivers of the Truck had procured the vehicle along with its loaded river bed material illegally and transporting the same for their illegal gain.

On further grilling they discloses that they along with the owner of the Truck in association with others had procured the river bed materials, pebbles illegally from Bedgara Riverside and carrying/transporting the same to Salugara Bazar for their wrongful gain without any valid documents. Hence, I seized both the Truck having No **WB-65/5517** and **WB-76/2145** along with loaded sand under proper seizure list and arrested both the drivers of the Truck U/s 41 Cr.P.C under proper Memo of Arrest after explaining the reason of arrest to them. The whole process of search, seizure and arrest took place in between 08.30.hr to 09.30 hrs.

Under the circumstances, I pray before you that kindly initiate a specific case against the two arrested accused persons 1) Kalu Paswan (28 yrs) S/O Lt. Ram Avtar Paswan of Prakashnagar W/No. 43 PS Bhaktinagar Dist. Jalpaiguri 2) Tapan Das (35 yrs) S/O Lt. Tarani Das of Midle plus Debidanga PS Pradhannagar Dist. Darjeeling along with their owner of vehicle Registration No. WB-65/5517 and WB-76/2145 and others under proper section of law and cause its investigation.
