Sir,

With due respect, I am producing herewith one arrested accused person namely Kamlesh Singh (36) s/o Lt. Moni Singh of Bhaktinagar, Jantapara, Ward No.- 35, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

- I. 18 (Eighteen) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml.)
- II. 08 bottle of Officer Choice Dulex Whiskey containing 180 ML in each Bottle.
- III. 06 (Six) bottle of Kingfisher Strong Premium Beer containing 650 ML in each Bottle.

I, ASI Sajal Das presently attached with NJP PS under your kind control beg to state that today i.e. on 06.08.2022 at 0625 hrs I received a secret source information that one person namely Kamlesh Singh (36) s/o Lt. Moni Singh of Bhaktinagar, Jantapara, Ward No - 35, PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his hotel style 'Anjana Hotel' under PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide direction and instruction myself along with HG/794 Ranjit Roy, VP/08 Laxman Roy, CV/116 Rohit Kumar Mahato all of NJP PS, SPC left for NJP Hotel Line, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 0635 hrs we arrived at NJP Hotel Line at Anjana Hotel, PS- NJP, Dist.- Jalpaiguri, and being identified by the source I held raid at the Anjana Hotel of the said accused and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at his hotel since long for his illegal gain. On search the above noted I/D liquor recovered from his Hotel. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his Hotel. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 0725 hrs to 0805 hrs

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Kamlesh Singh (36) s/o Lt. Moni Singh of Bhaktinagar, Jantapara, Ward No.- 35, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
