Sir,

In producing here with the seized articles viz:-

- (i) 02 (two) no's Indane domestic Gas Cylinder partially loaded
- (ii) 01 (one) gas pipe length about 04 (four) fit with fitted one gas Regulator

under proper seizure list. I SI Pradip Chakraborty of Enforcement Branch, Siliguri Police Commissionerate do hereby lodge a written complaint against the owner namely Sanjit Saiba (35yrs) S/O Dhaniram Saiba of Kathalguri, Saraswastipur, PS- NJP, Dist- Jalpaiguri owner of "TEESTA RIVER RESTURANT" of Canal Road, Milanpally Near Teesta Barage, Gajaldoba, PS NJP, Dist- Jalpaiguri. Who was illegally procured the domestic Gas cylinder at his Restaurant styled as "TEESTA RIVER RESTURANT" for commercial purpose without any valid documents or licence to the effect that today i.e. 06.08.22 at about 12:45 hrs received an information from reliable source that above noted restaurant styled as "TEESTA RIVER RESTURANT" situated at above mentioned addressed using the domestic Gas cylinder at his restaurant for using commercial purpose for wrongful gain.

Accordingly, the matter informed to ACP EB SPC and as per his direction I, along with, ASI Prashanta Bardhan, ASI Ashoke Biswas, C/424 Manik Roy, CV/019 Debendra Nath Roy all of EB SPC to accompanied with Sri Andnda Bishal Inspector EB, SPC with investigation kit left for NJP PS area vide EB SPC C.C No 116/22 Dt. 06.08.2022. The matter informed to NJP PS for providing police assistance vide NJP PS GDE No. 295 dated 06/08/22. At 13:35 hrs myself along with ASI Sanjay Saha, NVF C/997 Amal Ch Barman 159 Debranjana Sarkar, of Mobile van (Milanpally OP) vide MCC NO 887/22 Dated 06/08/2022 had been to Canal Road, Milanpally Near Teesta Barage, Gajaldoba, PS NJP, Dist- Jalpaiguri to work out the information and apprised them about the information in hand and requested them to accompany with us during search and seizure. As per source information we reached and entered into the Restaurant styled as "TEESTA RIVER RESTURANT" situated at Canal Road, Milanpally Near Teesta Barage, Gajaldoba, PS NJP, Dist- Jalpaiguri. During search found worker of restaurant cooking food items by using the domestic Indane Gas cylinder without any valid documents for commercial purpose. On demand they failed to produce any valid documents in support of using the Indane domestic gas cylinders in the kitchen of said restaurant for commercial purpose. Further local enquiry it revealed that the above noted restaurant owner is using the domestic gas cylinder for preparing Food Items at the Restaurant for commercial purpose in order to wrongful gain without any valid document. I also invited two independent witnesses namely (1) Prakash Mangar (35yrs) S/O Gopal Mangar of Saraswatipur, N.P line, PS- NJP, Dist. Jalpaiguri (2) Pappu Saiba (26yrs) S/O Bipen Saiba Saraswatipur, N.P line, PS- NJP, Dist. Jalpaiguri, (3) CV/019 Debendra Nath Roy of EB SPC.

During local enquiry it could be learnt that the Restaurant owner namely Sanjit Saiba owner of "TEESTA RIVER RESTURANT" of Canal Road, Milanpally Near Teesta Barage, Gajaldoba, PS NJP, Dist- Jalpaiguri using the domestic gas cylinder abundantly for commercial purpose. Subsequently I seized the above noted articles from his restaurant styled as TEESTA RIVER RESTURANT, staff of the restaurant unable to produce any supporting documents for using domestic gas cylinder at their restaurant for business purpose. Seized the articles from the restaurant after preparing proper seizure list and label in the presence of witnesses noted above. The seizure was made in between 15:20 hrs to 15:45 hrs. But found the owner of restaurant Sanjit Saiba absconded from the shop to evade police arrest to seeing the police party.

Hence, I pray that specific case may kindly be started under section 285 IPC r/w 7(i)(a)(b)(c) of Essential Commodities Act 1955 against the accused person namely Sanjit Saiba (35yrs) S/O Dhaniram Saiba of Kathalguri Saraswastipur, PS- NJP, Dist- Jalpaiguri owner of Restaurant Styled as "TEESTA RIVER RESTURANT" situated at Canal Road, Milanpally Near Teesta Barage, Gajaldoba, PS NJP, Dist- Jalpaiguri and arrange for its investigation.
