FIR - ILLEGAL CONSTRUCTION NEAR DEFENCE LAND IN AREA MOUZA KHAPRUL

1. It is intimated that despite concerted efforts by unit personnel and repeated warnings, illegal construction activities are still going on in area Mouza Khaprul. One more incident of illegal construction behind Officers Mess of this unit has come to notice wherein an individual named Mr Abhishek Attri. S/o Sanjay Attri is carrying out construction at Pholbari, Mouza Khaprul within 100 Mtrs of defence land without obtaining No Objection Certificate from Stn HQ Sukna, which is illegal.
2. It is also intimated that when the unit personnel approach the representative of above mentioned individual Mr Rishi present at the construction site to halt the construction immediately. Mr Rishi entered into an altercation and also physically assaulted the troops patrolling the area.
