Sir,

In producing herewith one arrested accused person namely Paran Barman (20), S/O- Paresch Barman of Parimalnagar, PO+PS Matigara, Dist Darjeeling, along with one seized blue colour Tata ACE vehicle bearing registration No- WB- 73-D-0226 under proper seizure.

I, PSI Shekhar Adhikary of Matigara Police Station, Siliguri Police Commissionerate do hereby lodge this complaint against above noted arrested person namely Paran Barman (19), S/O- Paresch Barman of Parimalnagar, PO+PS Matigara, Dist Darjeeling, to the effect that today on 09/08/2022 at 14:00 hrs onwards while performing evening van duty vide Matigara PS GDE No- 452/22 dated 09/08/22 received a specific source information that one Tata ACE vehicle bearing registration No- WB- 73-D-0226 loaded with illegal river bed materials is coming from Parimalnagar Ghat under Matigara PS. Accordingly I informed the matter to the O/C PS and being directed by the O/C PS I along with assisting force left towards Parimalnagar Ghat to verify the veracity of source information. On the way towards Parimalnagar Ghat, under Matigara I detained the said vehicle at Sutki Godown which was coming towards Matigara with loaded river bed materials. Subsequently I stopped the vehicle and asked for documents for carrying the river bed materials. But the driver named Paran Barman failed to produce any valid documents for carrying the same. Therefore, I apprehended the driver of the said vehicle who on being asked disclosed his identity as Paran Barman (19), S/O- Paresch Barman of Parimalnagar, PO+PS Matigara, Dist. Darjeeling.

Accordingly, I seized the said blue colour Tata ACE vehicle bearing registration No- WB- 73-D-0226 under proper seizure list and subsequently arrested the driver named Paran Barman (19), S/O- Paresch Barman of Parimalnagar, PO+PS Matigara, Dist Darjeeling following all formalities. The whole process of seizure and arrest was made in between 17:05 hrs to 17:55 hrs.

Hence, I pray that a specific case may kindly be started against the driver Paran Barman (19), S/O- Paresch Barman of Parimalnagar, PO+PS Matigara, Dist Darjeeling under proper section of Law and arrange for its investigation.
