Sub: First Information Report

Respected Sir,

I, the undersigned would like to draw your kind attention towards an untoward incident that took place with me yesterday. Yesterday night at around 11:30 pm when I was leaving from Planet mall on my home in my car along with some friends, 4 unknown miscreants in bike stopped me while I was leaving and they forcefully thrown my friends out of the car and kidnapped me, ^{showing knife} ~~on gun point~~. They had beaten me in the car very brutally and was making a video of it as if they miscreants were doing all this by following someone's instructions.

They threatened me with dire consequences if I do not follow what they say. I was trying to escape from their grip while they were kidnapping me in my vehicle.

They took me through Darjeeling More towards Khoprail More, I could not see any police patrol van or any person

from whom I will be able to take some help, finally while
they were taking me ^{through} ~~from~~ the BSF camp, I gathered
all my courage and saved my life by jumping out of the
car. Then ~~to~~ out of fear and despair I jumped the
gate of the BSF Camp to ensure my safety.

Subsequently, these unknown miscreants fled from the
place taking my vehicle bearing registration no. WB 74 BG 8359, ^{Tata} Harrier 2021,
my mobile phone, laptop, one gold chain and cash rupees of Rs. 1 lakh
(approx).

I therefore request you to immediately intervene into this
matter and thereby initiate appropriate criminal proceedings against
these unknown miscreants and thereby punish them for commission of
such heinous offences.

Hope you will do the needful at your earliest.
