With due respect and humble submission, in producing herewith two accused namely (1) Siddarth Paswan @ Siddharth Kumar (20) S/O Ram Laxman Paswan & (2) Rohit Kumar Paswan (22) S/O Jagdish Paswan both of Akmighat, P.S- Bahadurpur, Dist. Darvanga, Bihar (Not Verify) under arrest along with following articles under proper seizure;

- i) **65(Sixty five)** Pouch Packet of Officer Choice, Deluxe Whisky, each containing 180 ML and each MRP 130/- Manufactured by: Allied Blenders and Distillers Pvt. Ltd, Kalyani Industrial Growth Centre, Phase -III, Plot No. B& G, Barrack Poire, Kalyani Express Highway Dist. Nadia, West Bengal, (total 11,700 Liters), seized from the possession of Siddarth Paswan @ Siddharth Kumar, Marked as "Exhibit -A"
- ii) **01(One)** Pouch Packet of Officer Choice, Deluxe Whisky, containing 180 ML - taken out from exhibit "A" as sample for examination and marked as "exhibit -A-1"
- iii) **80(Eighty)** Pouch Packet of Officer Choice, Deluxe Whisky, each containing 180 ML and each MRP 130/- Manufactured by: Allied Blenders and Distillers Pvt. Ltd, Kalyani Industrial Growth Centre, Phase -III, Plot No. B& G, Barrack Poire, Kalyani Express Highway Dist. Nadia, West Bengal, (total 14,400 Liters), seized from the possession of Rohit Kumar Paswan, Marked as "Exhibit -B"
- iv) **01(One)** Pouch Packet of Officer Choice, Deluxe Whisky, containing 180 ML - taken out from exhibit "B" as sample for examination and marked as "exhibit -B-1"

I ASI Manoj Kr Roy of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted two accused persons to the effect that today on 11.08.22 myself along with force, C/762 Mojibar Rahaman CV/128 Ajay Kr Sahani, CV/242 Rakesh Mangar all of Pradhannagar PS was performing special mobile at PS area vide Pradhannagar PS GDE No. 709 dtd. 11.08.22. During patrolling at 19.10 hrs, I received a source information that two person has standing at Nividita Road, near Margarete School gate under Pradhannagar PS with two Laptop bag with huge quantity liquor. Accordingly I informed to you and as per your direction myself along with force arrived at Nividita Road, near Margarete School gate at 19.25 hrs and after arrival the spot I contacted with the source and the source identified them, accordingly we are apprehend them at Nividita Road, near Margarete School gate under Pradhannagar PS and on interrogation they disclosed their name noted above, they also stated that they carrying the liquor illegally to sell the same in Bihar for their wrongful gain. Accordingly I search the bags and recovered above noted articles, on demand they failed to produce any valid document or license in respect of recovered articles. Hence I seized & label the above noted articles in presence of witnesses. The seized and label was made in between 19.55 hrs to 20.25 hrs and I arrested them.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely (1) Siddarth Paswan @ Siddharth Kumar (20) S/O Ram Laxman Paswan & (2) Rohit Kumar Paswan (22) S/O Jagdish Paswan both of Akmighat, P.S- Bahadurpur, Dist. Darvanga, Bihar and arrange for its investigation.
