With due respect and humble submission, in producing herewith one accused namely Gouri Shankar Sah(50) S/O Sri Ambika Sah of Lagoni, P.S- Masara, Dist. Chapra, Bihar A/P Chotalal Hotel at Regulated Market Gate No.-1, P.S-Pradhannagar, Dist. Darjeeling under arrest along with following articles under proper seizure ;

- i) 20 (Twenty) Plastic bottles of Himalayan Gold, Country Spirit, 60* up each bottle containing 600 ML. (total 12 liters)

I ASI Tarun Kanti Ghosh of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that on 11.08.22 in course Special mobile duty at PS area with force Const/762 Mojibar Rahaman ,CV/646 Baban Das all of PDN PS vide PDN PS GDE NO 719 dtd.11.08.22 , I received an information that one person namely Gouri Shankar Sah is storing and selling liquor illegally in his hotel styles as " Chota Lal Hotel " at Regulated market gate No.1 under Pradhannagar PS .Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and as pointed by the source we apprehended the above noted person and on search his hotel recovered above noted articles , On demand he failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he is selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 23.15. hrs to 23.45 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Gouri Shankar Sah(50) S/O Sri Ambika Sah of Lagoni, P.S- Masara, Dist. Chapra, Bihar A/P Chotalal Hotel at Regulated Market Gate No.-1, P.S-Pradhannagar, Dist. Darjeeling and arrange for its investigation.
