I Mr. Piyas Khan, s/o Abdul Qafar Khan, resident of Ashraf Nagar Sakon Mandir road, ward NO-40 of S.M.C, distt:- Jalpaiguri, begs to state as follows:-

① That on 09.08.22 which was a day of Muharram which was being observed at Hill Cart Road since evening. I along with my family including my wife Anna Khatoon and my daughter went to see the occasion. At around 11:00 AM on reaching Sevoke more near Channapatti, my family and myself got down from our vehicle being no. WB 74J 6984 to eat some street food. At the very spot one Raja Ansari, s/o Samullah Ansari, R/o Ashraf Nagar, Sakon Mandir road and his brother Mister, were sitting on their scooty near the food stalls, where my family was enjoying the street food and the Muharram process, Raja Ansari along with his brother Mister started passing bad comments on my wife and saying "kya Naal hai"

Received on 12.08.22 at 13:00 hrs vide my PS WPE No- 732 dt- 12.08.22 and started sig PS case No- 769/22 dt- 12.08.22 v/s- 34/309/224/354B/379/509/34 IFC and endorsed to ASD Raju Sarkar for investigation

when my wife and myself asked them not to do so, Raja Ansari got very furious and pulled my wife's hand and down her clothes and said do whatever you can do and when went inbetween to make them understandy the said Raja Ansari and his brother assulted me with fist and blows and kicks and also tried to hitt on my head with the iron sword and further said that if I make any complain they would kidnap my minor daughter and kill her. In the mean time they also snatched my gold chain and cash supes 2000/-. When I resisted the said Raja Ansari and his brother again hit me hard on my forehead just above my right eye and I received injuries for the same.

② That seeing me being beaten by the said Raja Ansari and his brother mercilessly my wife seized me and cry to save me and seeing this

both of them assaulted my wife
also and beaten her also with
iron rod, kicks and blow. when the
people saw them beating my wife
then the people near by came
for help and they fled away
from the spot.

③ That there after ~~we~~ I got myself
admitted in the Siliguri district
hospital where I was give a first
aid treatment.

I therefore request you to
kindly take necessary legal action
against the afore said Raja Ansari
and his brother.
