I Kushal Bhattacharya, S/o. D.N. Bhattacharya, a resident of Flat No C-3, Krishna Kuthir, Uday Shankar Sarani, Deshbandhupare, Dist. Darjeeling Siliguri 734004. was travelling towards my home at around 9.30pm near Bypass road to Mahabristan from Court More. Suddenly 2 or more people started hitting at my car near the 2-wheeler stand nearby. When I stepped down of my car a group of people including Sandip Rai attacked me with stones & rod and left injuries near my left eye and left ear.

I am lodging a case against Sandip Rai & friends, Attached is the medical report. Delay in report is caused by the medical report.
