I would like to report that yesterday i.e. on 11.08.2022 after my office hours I went to my residence leaving Court at 5:30 p.m. Just after some time at 5:39 pm I received a phone call at my official mobile number from 8972269423 number who informed over telephone that his name is Subodh Oraon, that he is a railway staff and he found my wallet on the railway track near Rangapani Station. Then I checked my hand bag and found my wallet missing therefrom. Thereafter I sent PSO Shisir Debnath to get my wallet from him. After receiving my wallet I found that the cash amount of Rs. 600/700 and a locker key of Almirah were missing from the wallet. Apart from that my two ATM cards- one of SBI Bank and another of Bandhan Bank, my Voter ID card, PAN Card, Aadhar Card and official Identity Card and some bills and my passport sized photographs were kept intact in the wallet.

This is to further inform that for the whole Court hours my hand bag was kept in my chamber situated at 2nd floor of the Siliguri Court building and I went to the 1st floor where my ejlash is situated. No padlock was put on the door of my chamber when I went to hold ejlash yesterday.
