With due respect I Susanta Das resident of Deshbandra para, Siliguri would like to let you know yesterday night I was at my In-laws house as my father in-law and my brother-in-law both not present in Siliguri, both of them are in Delhi for business purpose.

Yesterday night nearby 1 A.M. local Bittu Ghosh and his father Jayanta Ghosh along with his wife attacked to my in-laws house, they came with 8-10 boys and attempted to kill us.

Ms. Jayanta Ghosh and Bittu Ghosh hit me and attacked to all ladies of my family (i.e. My wife and my mother-in-law), they snatched my gold chain yesterday night.

Bittu Ghosh repeatedly calling my brother in law and threatening him by using foul language.

Jayanta Ghosh and Bittu Ghosh both are attacking at my in laws home again and again, they are threatening to kill us, all of them attacked with sharp objects.

They are attempting to murder me, my spouse and my family members.

Considering the situation we are very scared and want justice.
