Sub: - **FIRST INFORMATION REPORT**

Respected Sir,

I, Rishi Sharma the undersigned would like to draw your kind attention towards the fact that today at around 12:30 pm to 01:30 pm I received a call from the labours appointed by me for construction of boundary walls around my land, in the call they stated that some army personnels have come there and have stopped their work out there illegally without any authority. After getting this information I reached the place, i.e., Taranju Bari as soon as possible. After reaching the spot I saw that one Major R. Upadhyay Quarter Master 5033 ASC Battalion, 99 APO and other 5 unknown persons were beating the labours very badly with sticks (lathis) and fists when I intervened into the matter and asked them why are they beating them, without giving me any answer they started to slap me, slang me and hit me and my partner Kuber Vardhan Mishra with fists and blows. They have also pinned me in the ground and tried to choke me to death at one point.

They have dragged me and my partner into their gypsy van forcefully and took us in their office and detained us there very illegally. After some time the said Major R. Upadhyay accompanied with 5 unknown persons in their civil dress entered into the office and they further threatened us that if we make any complain or lodge any F.I.R. against them then he will burn our shop at night, he even threatened us by saying that if we say a single word outside about this incident then he will falsely implicate us in case and will implicate us as a national threat and will detain us and will make sure that we rot in jail. The said Major R. Upadhyay have beat me with fists and blows in his office and have pinned me in the wall and tried to choke me. They made it known that

they don't fear or have any respect for the law of the land and is so powerful that I can never do anything to him or stand against him in any manner. They finally throw us out their office wounded and injured after beating.

In view of the above facts and circumstances, I do most humbly pray before your good office to take stern legal action against Major Upadhyay and his companions 5 unknown persons for commission of heinous offences as unveiled hereinabove and kindly book them according to the provisions of law and oblige.

Hope you will do the needful at your earliest.
