This is not the first incident where he demanded money from me. He use to physically assault me and my 7 year old son who cannot walk due to medical problems almost everyday but in order to protect our marriage I use to forgive him thinking he would change his behaviour and change himself for better. But I have completely lost faith in him and I am even afraid that he might come to my home and attack me and my son with the intention of killing us as he has promised the same over the phone.

Sir, I request to you kindly to investigate the matter seriously and to take necessary action into the matter to save our lives.
