Sir,

I, Abhishek Roy, S/o Jagadish Chandra Roy station manager of Matigara CCC, WBSEDCL hereby lodge complain against Md. Kale & Md Akram (both names are unverified, names gathered from local people refused to provide written copy) and two unknown person (as per CCTV footage) who are came to Matigara CCC on 11.08.2022 at 10.05 p.m. and hackle Mr. Kuntal Bhattacharya (on duty C.F.O) and Mr. Ankit Saha (on duty security guard). As per information provided by on-duty CFO and security guard total four person arrived the office and started abusive language and one person out of four people physically hacked and injured Kuntal Bhattacharya in backside of head, Ankit Saha has been slapped beside his eyes by the same person whose picture as per CCTV footage is enclosed. Phone receiver has been damaged during this incident, causing communication service defective for a certain period of time. The gang of these four people left office campus at 10.20 pm. Mr Kuntal Bhattacharya and Ankit Saha both are taken to Emergency Ward of Matigara B.P.H.C Darjeeling at 11 PM on dated 11.08.2022.

The whole incident occurred during power outage of Patiram 11 KV feeder fed from Khapraail 33/11 KV substation. The power restoration work is completed at 12.20 AM on 12.08.2022.

The names are found from local inquiry they may differ from actual. So I request you to kindly lodge complain for hampering Govt./Emergency work and hacking on duty staff and investigate the same for quick resolving the issue. Please accept this letter as F.I.R. Your cooperation in this regard is highly solicited.
