Sir,

With due respect and humble submission, in producing herewith one accused namely Dilip Roy (33) S/O Manaranjan Roy of Sankar Pu, P.S- Raiganj, Dist. Uttar Dinajpur (Not verified) under arrest along with following articles under proper seizure ;

1. 18(Eighteen) bottles of Kingfisher STRONG PREMIUM BEER each bottle containing 650 ml. each
MRP .120/- (total 11,700 liters)

I ASI Manoj Kr Roy of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 13.08.22 in course spl mobile van duty at PS area with force CV/128 Ajay Kr Sahani , CV/242 Rakesh Mongar vide PDN PS GDE NO 862 dtd.13.08.22 , at 20.05 I received an information that the owner of Nana hotel with the help of worker is storing and selling liquor illegally in the said hotel at Darjeeling more under Pradhannagar PS .Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and as pointed by the source we apprehended the above noted person and on seeing police party the owner of the hotel fled way from hotel and on search the hotel recovered above noted articles , On demand apprehended person failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he along with his owner namely Swashesh Tamang is selling the same illegally without obtaining valid document for their illegal gain. Accordingly, I seized & label the above noted articles in between 20.25 hrs to 20.55 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Dilip Roy (33) S/O Manaranjan Roy of Sankar Pu, P.S- Raiganj, Dist. Uttar Dinajpur (Not verified) and owner of the hotel namely Swashesh Tamang and arrange for its investigation.
