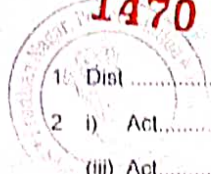

With due respect and humble submission, in producing herewith one accused namely Bikash Das (29 S/O Nagen Das of Jori Chhat Bhakal ,P.S- Boxirhat,Dist. I ASI Tarun Kanti Ghosh of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 13.08.22 in course spl mobile van duty at PS area with force CV/223 Swapan Chettri ,CV/646 Baban Das vide PDN PS GDE NO 862 dtd.13.08.22 ,at 19.45 I received an information that the owner of Kiran hotel with the help of worker is storing and selling liquor illegally in the said hotel at Darjeeling more under Pradhannagar PS .Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and as pointed by the source we apprehended the above noted person and on seeing police party the owner of the hotel namely Lakhi Yalmo fled way from her hotel and on search the hotel recovered above noted articles , On demand apprehended person failed to produce any valid document in respect of recovered articles .On interrogation he admitted that he along with his owner namely Laxmi Yalmo is selling the same illegally without obtaining valid document for their illegal gain. Accordingly, I seized & label the above noted articles in between 20.05 hrs to 20.35 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Bikash Das (29 S/O Nagen Das of Jori Chhat Bhakal ,P.S- Boxirhat,Dist. Coochbehar A/P Linton Talukder of Lexicon More ,P.S-Matigara, Dist.Darjeeling and owner of the hotel namely Lakhi Yalmo and arrange for its investigation.
