With due respect and humble submission, in producing herewith one accused namely Rabindra Sha S/O Gouri Shankar Sah of Gandhinagar, P.S-Bhaktinagar, Dist. Jalpaiguri under arrest along with following articles under proper seizure ;

- i) 12(Twelve) bottles of TUBORG PREMIUM STRONG BEER each bottle containing 650 ml. ,each MRP 120/- (total 7,800 liters)

I ASI Manoj Kr Roy of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 13.08.22 in course spl mobile van duty at PS area with force CV/128 Ajay Kr Sahani, CV/242 Rakesh Mongar vide PDN PS GDE NO 883 dtd.13.08.22 ,at 23.05 hrs ,I received an information that the one person namely Rabindra Sah is storing and selling liquor illegally in the said hotel style as Chotta Lal Hotel at Regulated market gate No.1 under Pradhannagar PS .Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and as pointed by the source we apprehended the above noted person and search the hotel recovered above noted articles , On demand apprehended person failed to produce any valid document in respect of recovered articles .On interrogation he admitted that selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 23.15 hrs to 23.45 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Rabindra Sha S/O Gouri Shankar Sah of Gandhinagar, P.S-Bhaktinagar, Dist. Jalpaiguri and arrange for its investigation.
