With due respect and humble submission, in producing herewith one accused namely Ashoke Lama (49) S/O Lt Jasbur Lama of Madhuban bagan ,P.S-Madarihat,Dist.AlipuarduarA/P Gupta Hotel ,Darjeeling more P.S-Pradhannagar,Dist.Darjeeling under arrest along with following articles under proper seizure ;

1. 20 (Twenty) Plastic bottles of Himalayan Gold, Country Spirit, 60* up each bottle containing 600 ML. (total 12 liters)

I ASI Tarun Kanti Ghosh of Pradhannagar PS, SPC would like to lodge this written complainant against the above noted accused person to the effect that today on 13.08.22 in course spl mobile van duty at PS area with force CV/645 Pankaj Gupta ,CV/223 Swapan Chettri vide PDN PS GDE NO 883 dtd.13.08.22 ,at 23.10 hrs ,I received an information that the one person namely Ashoke Lama is storing and selling liquor illegally in the said hotel style as Gupta Hotel at Darjeeling more under Pradhannagar PS .Accordingly, I share the information to you and as per your kind instruction myself along with force rush to the spot and as pointed by the source we apprehended the above noted person and search the hotel recovered above noted articles , On demand apprehended person failed to produce any valid document in respect of recovered articles .On interrogation he admitted that selling the same illegally without obtaining valid document for his illegal gain. Accordingly, I seized & label the above noted articles in between 23.25 hrs to 23.55 hrs and I arrested him.

Therefore, I request you to start a specific case under proper section of law against the arrested person namely Ashoke Lama (49) S/O Lt Jasbur Lama of Madhuban bagan ,P.S-Madarihat,Dist.AlipuarduarA/P Gupta Hotel ,Darjeeling more P.S-Pradhannagar,Dist.Darjeeling and arrange for its investigation.
