In producing herewith arrested accused lady namely (i) Laxmi Sarkar(28yrs), W/o-Amulya Sarkar of Mahabhirstan near Sabji Market, W/no- 28, PS- Siliguri, Dist-Darjeeling arrested u/s- 41 Cr.P.C along with following seized articles viz: i) Twelve (12) Bottles Sealed Himalayan Gold premium 60 Up Country Spirit each containing 600 Ml each labeled as Himalayan Endeavour PVT Ltd. Siliguri, West Bengal @ Rs 120 each(Amounting of Rs. 120/-*12=Rs 1440/-), in which one sealed bottle has taken from mother packet box as sample under proper seizure list, labeling and memo of arrest.

I, ASI Debasish Das of Siliguri PS, Siliguri Police Commissionerate do hereby lodge this written complaint against the above noted accused person namely Laxmi Sarkar (28yrs), W/o-Amulya Sarkar of Mahabhirstan near Sabji Market, W/no- 28, PS- Siliguri, Dist- Darjeeling to the effect that on 13.08.22 at 14.35 hrs acting on secret source information that the above noted person was busy to sale Id Liquor illegally at her shop situated at Tikiapara, Matangini- II, W/no-28 under Siliguri PS in order to clandestinely dispose the same. Accordingly I informed the fact to IC Siliguri PS and as per his direction I along with other officer and forces and lady forces left for Tikiapara, Matangini, W/no-28 under Siliguri PS vide GDE no- 793 dated 13/08/22. On reaching at 14:45 hrs there and as identified by the source cordoned the above noted area where she was selling illegal alcohol. On seeing the police party the above noted lady tried to escape from the spot but with the help of LC 1295 Swastika Rai we manage to apprehend the above noted lady and on interrogation she disclosed her identity as noted above. On being asked she stated that she used to sale the 60 up country Spirit to locality without any valid documents as she violated the norms of Bengal Excise Act for selling the said Liquor without any valid License. On search Twelve (12) Bottles Sealed Himalayan Gold premium 60 Up Country Spirit each containing 600 Ml each labeled as Himalayan Endeavour PVT Ltd. Siliguri, West Bengal @ Rs 120 each(Amounting of Rs. 120/-*12=Rs 1440/-) in which one sealed bottle has taken from mother packet box as sample as per seizure list which was kept concealed in her shop situated at Tikiapara under Siliguri PS. On being interrogation she could not produce any valid documents in respect of said liquor. She also stated that she is doing this Liquor business since long for her wrongful gain. Accordingly I seized the same in presence of witness duly signed by them. The seizure and label was made in between 14:45 hrs to 15:15 hrs. As such I arrested her with the help of lady force LC 1295 Swastika Rai U/S- 41 Cr.P.C after observing all legal formalities.

Therefore I pray before your honor that a specific case may kindly be started against the arrested accused lady namely Laxmi Sarkar (28yrs), W/o- Amulya Sarkar of Mahabhirstan near Sabji Market, W/no- 28, PS- Siliguri, Dist-Darjeeling along with seized articles under proper section of law and arrange for its investigation.
