Sir,

In producing herewith one arrested accused person namely Ranjit Pandey 58yrs s/o Late Sankar Lal Pandey of Desh Bandhu Para near N.T.S More, Ward No-28 PS-Siliguri, Dist-Darjeeling along with seized articles:-

- 1] 10 (Ten) Bottles Country Spirit styled as Himalayan Gold 60 UP of 600 ml each, MRP Rs. 120/-
- 2] One Nylon Bag which used for carrying the seized articles SL. No. 1.

I, ASI Biswajit Saha of Panitanki TOP under Siliguri PS hereby lodge a written complaint against the above noted accused person to the effect that on 13.08.2022 at 15.25 hrs received one secret source information to the effect that one person is carrying huge quantity of bottled country spirit through Panitanki More towards Venus More, Siliguri. Accordingly the information was diarized vide Panitanki TOP GDE No. 298 dated 13.08.2022 and informed to O.C, Panitanki TOP and thereafter as per his direction I along with C/233, Nagen Chandra Barman, C/153, Santosh Mahato, C/702 Latifur Rahaman and C/ 984 Subhasish Das left from Panitanki TOP to work out the information. On arrival at Bidhan Market near Auto Stand, Siliguri at 15.45 hrs being pointed out by the source, found that one person is proceeding with huge quantity of country spirit containing with a Nylon bag. I intercepted the said accused person with loaded articles in presence of disinterested witnesses. During interrogation the accused failed to produce any documents/license in support of the same and stated that he sale the same to the local public at Deshbandhu Para N.T.S More adjacent area illegally with a view to earn huge money for his lively hood. Accordingly I seized (1) 10 (Ten) Bottles Country Spirit styled as Himalayan Gold 60 UP of 600 ml each, MRP Rs. 120/- and 2) One Nylon Bag which used for carrying the seized articles SL. No. 1 under proper seizure list and labeled the same in presence of witnesses and duly signed by them and also by the accused person. The seizure was made between 16.05 hrs. to 16.45 hrs. I then arrested the accused person u/s 41 Cr.P.C. after explaining charge against him. The local public was also annoyed with him because of his this kind of illegal activities. As such there was no scope to serve Notice u/s 41A of Cr.P.C.

Hence, under the above noted circumstances I am submitting this written complaint against the above accused person namely Ranjit Pandey 58yrs s/o Late Sankar Lal Pandey of Desh Bandhu Para near N.T.S More, Ward No-28 PS-Siliguri, Dist-Darjeeling for starting a specific case under proper section of Law and to arrange for its investigation.
