Sir,

With due respect and in producing herewith the arrested accused person namely Ranjit Sarkar (38), S/O Lt. Narayan Sarkar of Dakhin Palash, Notun Bazar, PS- Pradhan Nagar, Dist- Darjeeling with following seized articles :-

- One vehicle bearing Reg. No. WB 73/2425 loaded with River bed materials.

In this regard, I ASI Abdul Latif of Matigara P.S, SPC do hereby lodge this Complaint against above noted arrested accused person to the effect that on 13.08.2022 at about 13:05 hrs onwards I received a source information that one vehicle bearing Reg. No. WB 73/2425 loaded with River bed materials coming from Parimal Nagar Ghat without any valid documents. Accordingly I inform the fact to Officer In charge, Matigara PS and as per his kind direction myself along with force had been to Chang More under PS Matigara to work out the information in hand. After arrival of the spot I found said vehicle bearing Reg. No. WB 73/2425 loaded with River bed materials standing at Chang more under Matigara PS area. Accordingly, I apprehended the driver of the vehicle. On demand he failed to produce any valid documents in respect of river bed materials loaded in his vehicle. On further interrogation, he stated that he mines such river bed materials from Parimal Nagar Side by illegal means with a view to sell the same for his illegal gain. Accordingly, I seized the above noted vehicle loaded with illegally mining river bed materials under proper seizure list and arrested him after maintaining all formalities regarding arrest.

Therefore, I pray before you that a specific case under proper section of law may kindly be started against the arrested accused person namely Ranjit Sarkar (38), S/O Lt. Narayan Sarkar of Dakhin Palash, Notun Bazar, PS- Pradhan Nagar, Dist- Darjeeling or the owner of the vehicle and arrange for its investigation.
