Subj: - First Information Report.

Sir,

I Smt Chandrawati Prasad, who is Nandu Prasad, Resident of Hemant Basu Colony P.O. Siliguri, Dist - Darjeeling, do hereby lodge this complaint against Praveen Kumar Gupta and his father Anun Gupta, both residents of Silhi Residency, Bhambu Nagar under Ghahingul Police Station, District - Jalpaiguri to the effect that the said Praveen Kumar Gupta who happens to be my son-in-law along with his father Anun Gupta today at around 4:00 pm came to our residence at Hemant Basu Colony and started shouting from outside and then I went and asked them to come inside but they refused and said that today they will finish the game in front of whole locality. For about 20 mins I requested Praveen Gupta to come inside but thereafter he started abusing

me and family members with filthy languages. When my Son Sri Abhishek Prasad and my husband came downstairs the said Prasen Gupta called my Son - "ae malachod ke dhae aa" and caught hold of collar of my Son and started hitting with fists and blows. Aamir Gupta also started abusing my husband and soon thereafter when I was rescuing my son, the said Prasen Gupta hit me with punch in my chest and also torn my saree and blouse.

The said Prasen Gupta is a person of very dangerous and dominating nature and due to his hard hitting today my husband has suffered severe injuries in his neck and mouth, my son has also suffered injuries in neck and chest and I suffered injuries in my eyes and my whole body has swollen due to his punches and blows.

They have abused me and my family with sexist remarks and have badly assaulted us in front of whole locality.

I pray your good self to take necessary action and avert the culprit.
