Sir,

In producing here with the one arrested accused person namely Bikash Sahani (22) s/o late Sunil Sahani of rana busty, Railway colony, ward no 18 PS Siliguri Dist- Darjeeling along with Thirteen (13) bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 13 = Rs 1560/-)

I ASI Rabin lama of Siliguri PS under Siliguri Police Commissionerate do here by lodge a written complaint against the arrested accused person namely Bikash Sahani (22) s/o late Sunil Sahani of rana busty, Railway colony, ward no 18 PS Siliguri Dist- Darjeeling to the effect that on 13/08/2022 at 19.15 hrs I received a source information that one person standing at S.F Road near brand factory under Siliguri PS along with huge quantity of liquor. The fact was diarized in General Diary vide Siliguri PS GDE no 821 dated 13/08/2022, about the information share with I/C Siliguri PS and as per his kind direction, I along with ASI Siben Sarkar, ASI Debasish Das, CV/622 Ramanath Barman proceeded to the spot to work out the source information. At about 19.25 hrs I along with my accompanied team reached at S.F road near Brand Factory under Siliguri PS, on being shown by the source our police team detained the said person, along with Thirteen (13) sealed bottles of Himalayan gold 60 up country spirit each bottle containing 600 ml (total market value of RS- 120 x 13 = Rs- 1560. On interrogation he disclosed his identity as Bikash Sahani (22) s/o late Sunil Sahani of rana busty, Railway colony, ward no 18 PS Siliguri Dist- Darjeeling and he admitted that he sell the same to his design customers since long for his wrongful gain. On demand he failed to produce any valid documents or license in r/o said liquor. Therefore in reference to the statement made by the Bikash Sahani I seized the same viz; Thirteen (13) sealed bottles of Himalayan Gold 60 up country spirit each bottle containing 600 ml. (Total market value RS/- 120 X 13 = Rs1560/-) from the possession of Bikash Sahani (22) s/o late Sunil Sahani of rana busty, Railway colony, ward no 18 PS Siliguri Dist- Darjeeling (seizure and labelled was made between 19.35 hrs to 20.10 hrs) in presence of witnesses duly sign by the accused. As he violated the rules and norms of Bengal Excise Act, as such I arrested him u/s 41 Cr.P.C appraise him ground of arrest and issued arrest memo in presence of witnesses.

I, therefore pray before your kind honour to take legal action against the arrested person Bikash Sahani (22) s/o late Sunil Sahani of rana busty, Railway colony, ward no 18 PS Siliguri Dist- Darjeeling
