In producing herewith the arrested accused person namely Sanjib Das @ Doga (21yrs) S/o- Shambu Das of Bagrakote near Uttar Banga sambad, W/no- 20, PS- Siliguri, Dist- Darjeeling along with seized article viz:-


1. One improvised shutter iron made fire arms in working condition measuring length 9 inches approx from barrel to butt having striking pin, hammer and trigger marked as Exhibit- A
2. One live ammunition engraved KF 7.65 unreadable on its percussion cap (found loaded in SI No.1 seized exclusively from possession of accused Sanjib Das marked as Exhibit- B

I SI Haren Kumar Mahanto of Siliguri Police Station, Siliguri Police Commissionerate do hereby lodge this complaint that on 13/08/22 at around 21:25 hrs received a secret source information that one person was moving suspiciously at Children Park, back side of Siliguri College with an ulterior motive and is in possession of firearms. Diarized the matter vide Siliguri PS GD Entry no- 830 dated 13/08/22. Accordingly I informed the matter to I/C Siliguri PS and as per his kind instruction I along with ASI Rabin Lama, ASI Siben Sarkar, C/479 Dipak Chhetri and C/1409 Ananta Roy all of Siliguri PS rushed to the place at Children Park, back side of Siliguri PS vide GDE no- 831 dated 13/08/22 and on way picked up two disinterested witness namely (i) Sujit Sikder(21yrs) S/o- Madhav Sikder of Khudiram Colony, Bagrakote, w/no- 18, PS- Siliguri, Darjeeling and (ii) Rahul Paswan(23yrs) S/o- Ram Naresh Paswan of Khudiram Colony, Bagrakote, W/no- 18, PS- Siliguri, Dist- Darjeeling. At 21:55hrs I along with force reached at Children Park, back side of Siliguri College and as per identification by the source, myself along with force managed to apprehended the person. On being asked, the apprehended person disclosed his identity as noted above.

Accordingly, as per information and following all necessary procedures of search of the police person in presence of witness, search of the apprehended person Sanjib Das was made. On search one improvised shutter fire arm loaded with one(01) ammunition engraved KF 7.65 unreadable on its percussion cap was recovered which was kept concealed under his pant on the right side of his below the waist. The ammunition was loaded from the firearms as per practical experience. On being asked about the possession of the fire arms the apprehended Sanjib Das made incoherent statements. On being asked he failed to produce any valid documents in respect of said Fire Arms. On further interrogation he stated that he had procured the said Fire Arms illegally to intend to sale under Siliguri area for his wrongful gain.

As there is every reason to believe that the recovery firearms loaded with one round ammunition has been procured dishonestly by the apprehended Sanjib Das for his ulterior motive, seized the firearms and one round ammunitions duly taking its measurements and details in presence of the witnesses duly signed by them and acknowledge by apprehended Sanjib Das and arrested him following all formalities. The seizure/label was done in between 22:15hrs to 23:15hrs.


