Sub:- Complaint against my son Sri Gopal Roy and his so called wife Smt. Subarna Gurung for committing mental and physical torture upon me and ousted me from my own house forcefully.

Respected Sir,

With due respect I, SRI HIRENDRA CHANDRA ROY, Son of Late Mahim Chandra Roy, Resident of 188/19, Arunoday Kabiguru Sarani, Rabindra Nagar, Ward No. 21 of S.M.C., Siliguri, P.O. Rabindra Sarani, P.S. Siliguri, Dist. Darjeeling, Pin: 734006, would like to lodge this written complaint to the effect that I am a 75 years old aged Senior Citizen, suffering with severe old aged ailments and considering my age, my health condition is deteriorating day by day. Sir, I was an Employee of Bharat Sanchar Nigam Limited, in the Telecom Department at Siliguri and presently, I have been receiving pensionary benefit on the strength of my said service. Sir, I was married with Smt. Shankari Roy and during continuation of our marital life, she died on 25.02.2018, leaving behind me as her husband and our only son namely Sri Gopal Roy. It is to be mentioned here that during continuation of our marital life, in the year of 2004, I have purchased a plot of homestead land measuring 2 Kahtas 8 Chhataks or 0.04 Acres, together with a two storied old residential building, appertaining to and forming part of Plot No. 11598 (Part), recorded in Khatian No. 3627 of Mouza - Siliguri, J.L. No. 110(88), Touzi No. 3(Ja), Pargana - Patharghata, within the Ward No. XXI of Siliguri Municipal Corporation, under the Jurisdiction of Police Station -Siliguri, Sub-Division & A.D.S.R. - Siliguri, Dist. Darjeeling, by virtue of a Deed of Conveyance (Sale), executed by Sri Subal Chandra Dey, Son of Sri Surjya Kanta Dey of Rabindra Nagar, Siliguri, on 26.05.2004, from my own fund and thereafter, I have mutated my name in the Office of the B.L. & L.R.O. - Siliguri, and a separate Khatian has been opened in my name being L.R. Khatian No. 11643 and since then, I along with my wife (since deceased) and our only son Sri Gopal Roy have started to reside therein. Sir, it is pertinent to mention here that since the childhood of our only son, I along with my wife (Since Deceased) have been taking proper care upon my son towards his health, medication as well as his educational career and I being the father, have tried my level best to provide best education to my only son for his better future and to that effect, I have admitted my son in the Delhi

Public School at Siliguri wherefrom, he has completed his 9th Standard and thereafter, as per his desire, he left the said school and admitted in the Modella Caretaker School, Church Road, Siliguri and completed his 11th Standard in the year of 2016 and thereafter, he left his studies as per his own wish and desire and started to approach and provoke me to provide some financial assistance as he wants to join in a Private Company at Cooch Behar named as Orients Global Marketing Pvt. Ltd. and as per his demand, I used to pay Rs. 10,000/- only per month as per his demand and during his said work, I have incurred and paid more than a sum of Rs. 1,00,000/- only to him as per his demand with a hope that he will develop his future career and he will stand by me during my last stage but all my hopes have gone in vain. Thereafter, suddenly in the month of January, 2021, my son along with his two friends came to me and told me that he has left his said job and he wants to build-up a business with his said two friends and for that purpose, a huge amount of fund is required and also requested me to provide the said amount and considering his said request and believing his said version, I again paid more than a sum of Rs. 3,35,000/- only to my son in order to build-up his said business as per his demand though, it is very much within his knowledge that I am retired old aged person having no other source of income of my own save and expect my pension and out of the said pensionary benefit, I used to maintain myself and my son somehow but even after investing such a huge amount, he did not continue his said business properly and thereafter, I again paid and invested more than a sum of Rs. 1,00,000/- only towards the Account of his other businesses like Internet Cafe/Cyber Café and Medical Distribution Business named as "Roy Enterprise" though, the said business have not been continued by my son property. It is very painful to mention here that suddenly in the month of December, 2021, my son brought a women namely Smt. Subarna Gurung, aged about 40 years, who is much older than my son who is aged about 25 years, in my house without my consent and told me that he got married with the said lady and hearing the same, I became surprised and keep mum as I was not aware about the same at all and when I asked and made protest against my son about his said decision, he became furious and started to humiliate and threatened me in presence of the said lady and since then, my son has been residing with the said lady in my aforesaid premises without my consent. Sir, since the date of their residing at my aforesaid property, my son in conspiracy with the said lady have started to create tremendous torture upon me in order to grab my entire property by illegal means and day by day, they have increased the intensity of torture upon me and caused physical torture upon me in different ways and they in conspiracy with each other, have clearly stated that I have no right in and over my own property and

thereby, they are trying to oust me from the my aforesaid property forcefully for their wrongful and illegal gain. Suddenly on 31.07.2022, at midnight, my son with the instigation and provocation of the said lady namely Smt. Subarna Gurung, have attacked upon me with an sole intention to kill me and knowing their said intention, when I tried to make protest against their said illegal acts and activities, they have thrown me out of my own house forcefully and also threatened me with dire consequences by saying that if I again try to enter into my said house, they will not hesitate to destroy my life permanently and capture my entire property forcefully and due to their said acts and activities, I have passed the entire night outside the house and on the very next day i.e. on 01.08.2022, I have compelled to left my own house with a single wearing apparels in order to save my life and took shelter at my elder brother's house at Kamakhyaguri Bazar, P.O., P.S. & Dist. Alipur and since then, I have been residing there at the mercy of my elder brother and passing my days with extreme fear and anxiety.

I, therefore, being a senior citizen, fervently requesting you to look into the matter properly and please take necessary steps against my son Sri Gopal Roy and the said lady Smt. Subarna Gurung for causing mental and physical torture upon me and also evict them from my own house as per the provision of law so that, I can live and enjoy my remaining life in my aforesaid property peacefully and obliged thereby.
