Sub: Complaint against Saddam, Son of not known, resident of Ashraf Nagar, Ward No.40 of S.M.C., P.O. Haider Para, P.S. Bhaktinagar, Dist. Jalpaiguri.

Respected Sir,

I, **Sidharth Biswakarma**, Son of Late Mohan Biswakarma, resident of Shastri Nagar, Tiranga More, Ward No.41 of S.M.C., P.O. Sevoke Road, P.S. Bhaktinagar, Dist. Jalpaiguri, do hereby lodge a complaint against Saddam, Son of not known, resident of Ashraf Nagar, Ward No.40 of S.M.C., P.O. Haider Para, P.S. Bhaktinagar, Dist. Jalpaiguri to the effect that on 15-08-2022 at about 8:00 pm in front of Hansbela Ashram, ISCKON Mandir Road, while I along with two younger brother of my para were waiting my friend Sachin Ray sitting on maruti omni van, said Saddam armed with dau and belt physically assaulted me with fist and blows, kicks, belts and with dau, said Saddam also bite me with his teeth on my right ear and also pelted stones and bricks at the said vehicle and as a consequence damaged the said vehicle and when I along with the aforesaid younger brothers of my para sitting in the said vehicle raised hue and cry, my said friend said Sachin Ray came running and rescued me from his clutches but said Saddam also physically assaulted him. Said Saddam snatched away my gold iron ear ring, wrist watch and mobile phone with sim of V-7 Plus of Vivo company and keypad mobile phone with sim of my said friend.

Due to the said physical assault, I sustained cut injuries on my right ear, cut left maxilla, multiple belt abrasion and cut right elbow and sustained injury over my person and my friend also sustained cut injuries on right finger and on his back and thereafter I was taken to the Siliguri District Hospital, Siliguri.

That said Saddam is very desperate and dangerous person having no regards about the law of the land and he is an anti-social and habitual offender.

So, therefore, I humbly request your goodself to take necessary legal steps against the abovenamed person and booked him as per the provision of law at an earliest.

I shall remain ever grateful for the needful and be obliged thereby.
