In producing here with two arrested accused persons namely 1. Toseen (55 Yrs) S/O Gafoor of Rasul Pure, Dapheri, Mujaffar Nagar, Uttar Pradesh , Pin – 251309 and 2. Mohd.Zaheer (43 Yrs) S/O Md. Jamil of Mujaffar Nagar, PS. Kotowali, Uttar Pradesh , Pin – 251003 along with two number of Truck bearing reg:- UP15DT0776 and UP12AT7365 under proper seizure.

I, ASI Binay Subba of NJP PS, SPC hereby lodged a written complaint against the the above noted accused persons to the effect that on today ie. 13.08.2022 at about 00.15 Hrs I received a secret source information that above noted drivers are going to deliver two numbers of truck bearing registration number UP15DT0776 and UP12AT7365 at Assam Side and they will pass through Jotiakhali more. My source also informed that the persons are obtain the said truck by stolen means. Accordingly I diarized the fact in NJP PS GDE vide GDE No. 598/2022 dated 13.08.2022 and informed to O/C NJP PS, SPC about the information. As per direction of O/C NJP PS, SPC myself along with C/152 A. K. Mia and N-0064 Parimal Roy both of NJP PS, SPC left for Jotiakhali more to verify the veracity of information which refers to NJP PS GDE no- 594/2022 Dated 12.08.2022.

At 00.35 hrs myself along with force arrived Near Jotiakhali more and contacted with my secret source. Further myself along with force ambushed near Jotiakhali area. At about 00.55 Hrs my source point out two numbers of truck which coming from Siliguri side towards to Jalpaiguri, accordingly myself along with force stop those truck and found that the registration numbers of those trucks are matched with the registration number which were informed by my source i.e UP15DT0776 and UP12AT7365. There after I managed to stop both the vehicles and asked the drivers to produce the valid documents of said trucks but they failed to produce any documents against the two vehicles. On being asked they disclosed their identity as 1. Toseen (55 Yrs) S/O Gafoor of Rasul Pure, Dapheri, Mujaffar Nagar, Uttar Pradesh, Pin -251309 and 2. Mohd.Zaheer (43 Yrs) S/O Md. Jamil of Mujaffar Nagar, PS. Kotowali, Uttar Pradesh , Pin - 251003. Further I searched both the vehicle found that the Truck having registration no - UP15DT0776 contain with some Iron road and another is empty. Further on being asked the drivers also failed to give any satisfactory account into this score. Hence, it is clear that the drivers have obtained the vehicles by stolen or by any fraudulent means and also received the same in their possession with their knowledge and also assisted in disposing of the vehicle.
