Sir,

I PSI Arindam Saha of Matigara P.S, SPC do hereby lodge a Complaint to the effect that on 17.08.2022 at 14:05 hrs onwards I received a information from my reliable source that one vehicle Truck bearing Reg. No. WB - 71 1285 loaded with stolen river bed materials coming from Chowrangi more side . On receiving the information I along with available rush to the spot to work out the information. Under information and kind order of O/C Matigara P.S on arrival at Chowrangi More under Matigara P.S area, I found one vehicle Truck bearing Reg. No. WB -71 1285 loaded with river bed materials going towards Matigara area. Subsequently, I manage to stop the vehicle but the driver of the vehicle fled away from the area. As such I seized the above noted loaded vehicle under proper seizure list U/S- 102 Cr.P.C in presence of available witnesses as stolen recovery property loaded river bed materials and brought at P.S.

Therefore I pray before you a specific case may kindly be started against the owner / driver of the seized vehicle Truck bearing Reg. No. WB -71 1285 under proper section of law and arrange for its investigation.
