**Sub :- F. I. R.**

Sir,

With due respect, I undersigned beg to state that I along with my younger brother namely Anil Tsering Lama have purchased a piece of vacant land measuring about 10 khatas i. e. 5 khatas each (more described schedule 'A' &'B' below respectively.) From one Sri Lal Oraon s/o Budhu Oraon vide two 'Sale Deed ' bearing No 5144& 5143 respectively on 17 the June 2011 and the land is situated within Mouza Palash, plot No 1916& 1915 respectively and subsequently we have constructed cemented blocks around our plot and the afore-said land is in our actual khas and physical possession with proper payment of land tax.

Sir, I submit that last time when we went to visit our plot where we wanted to start our construction, suddenly Sri Petrus Oraon s/o Budhu Oraon a resident of Palash Champasari came to our plot and declared that our plot belonged to his brothers and that our plot is located far behind from our plot , so we should vacate our plot.

Sir, on the next day when we visited our plot, we were called upon to have a discussion where We presented our proof of being the actual owners of our land. But the discussion was not fruitful . Sri Sundar Oraon s/o Jagnu Oraon and Petrus Oraon s/o Budhu Oraon, both residents of Palash Champasari , objected without any genuine reason and started claiming to be the real owners of our land. The next day one of their friends called on the mobile insisting me to sell our land to him at Rs 20,00,000(Twenty Lakh) only which was a meagre amount compared to the present market value of our land, to which I denied .

Whenever we visit our plot, these people always come in a group and argue with us regarding the possession of the land. Last time we wanted to start the construction work and the raw material were also unloaded at our plot but we were not allowed to do any construction work by these people. I wanted to lodge a police complaint but I was on a very short leave , therefore I couldn't. On several occasions we have been threatened not to enter into our land as they claim that it is their land. In the year 2011 when we purchased this plot, we had built cemented blocks for demarcation of our plot but someone broke it in 2018 and again in the same year we built another one which is still intact. We are under constant mental harrasment, as they have threatened that our land is theirs and we should not claim for it. As I am a heart patient and such mental harrasment will only elavate my health problem.

Sir, they are with the knowledge likely to do wrongful loss to us and they came to us with the intention to grab our land.

Viewing these situations, we do not feel safe whenever we visit our land which we had bought after proper verification, registration and Mutation. We could not lodge a complaint for this due to shortage of time as we were on a very short leave and we had to leave the next day for Arunachal Pradesh where we are employed.

Under the above facts and circumstances, it is prayed before you that you will be pleased to take the investigation into the matter and further take proper action against the above named person who are trying to threaten and grab our land.
