With due respect, I am producing herewith one arrested accused person namely Jyanto Das (23) s/o Badal Das of Baladoba, Daspara, PS- South Salmara, Dist.- Hatsingmari, Assam A/P NJP Hotel Line, PS-NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

- I. 11 (Eleven) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml.)
- II. 08 (Eight) bottle of Kingfisher Strong Premium Beer containing 650 ML in each Bottle.
- III. 04 (Four) bottle Tuborg strong Premium Beer containing 650 ML in each Bottle.

I, PSI-Pradeep Diyali presently attached with NJP PS under your kind control beg to state that today i.e. on 13.08.2022 at 1805 hrs I received a secret source information that one person namely Jyanto Das (23) s/o Badal Das of Baladoba, Daspara, PS- South Salmara, Dist.- Hatsingmari, Assam A/P NJP Hotel Line, PS-NJP, Dist.- Jalpaiguri is selling ID liquor illegally at Hotel style as "LOKNATH HOTEL" under PS- NJP, Dist.-Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 633 dated 13.08.2022 and informed the fact to you. As per your kind direction and instruction myself along with CV/306 Biswajit Roy, VP/13 Jamirul Islam all of NJP PS, SPC left for NJP Hotel Line, PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 1815 hrs we arrived at LOKNATH HOTEL duly run by Jyanto Das (23) s/o Badal Das of Baladoba, Daspara, PS- South Salmara, Dist.- Hatsingmari, Assam A/P NJP Hotel Line, PS-NJP, Dist.- Jalpaiguri and being identified by the source I held raid at Loknath hotel of the said accused and managed to apprehend him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at Hotel located since long for his illegal gain. On search the above noted 1/D liquor recovered from his hotel. On demand he failed to produce any documents/license in respect of store/sale the 1/D liquor recovered from Loknath hotel. Accordingly, I seized the above noted 1/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 1945 hrs to 2025 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Jyanto Das (23) s/o Badal Das of Baladoba, Daspara, PS- South Salmara, Dist.- Hatsingmari, Assam A/P NJP Hotel Line, PS-NJP, Dist.- Jalpaiguri and arrange for its investigation.
