Sir.

With due respect, I am producing herewith one arrested accused person namely Pradip Das (59) S/O Lt. Fatik Das of Paschim Dhantala, P.S- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

- I. 13 (thirteen) bottles of Himalayan Gold 60 UP Country Spirit (each bottle containing 600 ml.)
- II. 07 (seven) bottle of Kingfisher Strong Premium Beer containing 650 ML in each Bottle.

I, ASI Sajal Das presently attached with NJP PS under your kind control beg to state that today i.e. on 14.08.2022 at 01.05 hrs I received a secret source information that one person namely Pradip Das (59) S/O Lt. Fatik Das of Paschim Dhantala, P.S- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his shop at Fulbari Parking under PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 648 dated 14.08.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/ 08 Laxman Roy, HG/794 Ranjit Roy all of NJP PS, SPC left for Fulbari Parking under PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 02.35 hrs we arrived at Fulbari Parking, PS- NJP, Dist.- Jalpaiguri and being identified by the source I held raid at the shop at Fulbari Parking of the said accused and managed to apprehend him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at the shop located since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 02.05 hrs. to 02.35 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Pradip Das (59) S/O Lt. Fatik Das of Paschim Dhantala, P.S- NJP, Dist.- Jalpaiguri and arrange for its investigation.
