With due respect, I am producing herewith one arrested accused person namely Ramesh Roy (52) S/O Lt. Rajdeb Roy of Rajaholi, near Bibadi sangha, P.S- NJP, Dist- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

- 1 14 (Fourtin) bottles of Kingfisher Strong Premium Beer containing 650 ML in each Bottle.

I, ASI Sajal Das presently attached with NJP PS under your kind control beg to state that today i.e. on 15.08.2022 at 02.05 hrs I received a secret source information that one person namely Ramesh Roy (52) S/O Lt. Rajdeb Roy of Rajaholi, near Bibadi sangha, P.S- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his shop at Kaccha gall under PS- NJP, Dist.- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 703 dated 15.08.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/ 08 Laxman Roy, HG/794 Ranjit Roy all of NJP PS, SPC left for Kacchagali under PS- NJP, Dist.- Jalpaiguri to work out the information in hand. At about 02.25 hrs we arrived at Kacchagali, PS- NJP, Dist.- Jalpaiguri and being identified by the source I held raid at the shop at Kacchagali of the said accused and managed to apprehend him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at the shop located since long for his illegal gain. On search the above noted I/D liquor recovered from his shop. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his shop. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 02.45 hrs. to 03.25 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Ramesh Roy (52) S/O Lt. Rajdeb Roy of Rajaholi, near Bibadi sangha, P.S- NJP, Dist.- Jalpaiguri and arrange for its investigation.
