With due respect I, Liton Mandal, son of Jagannath Mandal, presently residing at Fulbari, Battalion More, P.S. N.J.P., Dist. Jalpaiguri, permanent resident of Laxmi RBI Sarani, Milanpally, P.S. Siliguri, Dist. Darjeeling, would like to inform you that I am the customer of Vodafone Idea (VI) Telecom Company having a SIM card bearing number 8946000000. I have obtained the said Vodafone Idea (VI) SIM through my Adhar card bearing no. 8320-8252-3078 and I was using the said number since five years. Lastly I had recharged the said number in the month of July, 2022 of Rs. 99/-. Recently I have found that there was no network of the said Vodafone Idea (VI) number in my mobile phone. Accordingly on 17.08.2022 I called the customer care of Vodafone Idea (VI) company to know as to why the said number is not in order. Customer care replied me that the said number which was Vodafone Idea (VI) has been ported to other company. I immediately informed him through conversation that I never ported my said number 8946000000 to any other mobile network. The SIM card is still lying with me. Thereafter I went to the local Vodafone Idea (VI) Mini store to appraise them the problem. They surprisingly informed me that someone manufacturing a false Aadhar card or Voter Card etc. in my name
