Sir,
With due respect, I am producing herewith one arrested accused person namely Rubel Hoque (25) S/O Yaiab Ali of Atia bari, PS- Sahebgang, Dist- Coochbehar. The ground of arrest duly been communicated with him.

1. 13 (Thirteen) bottles of Kingfisher Strong Premium Beer containing 650 ML in each Bottle

I, ASI Sajal Das presently attached with NJP PS under your kind control beg to state that today i.e. on 17.08.2022 at 18.25 hrs I received a secret source information that one person namely Rubel Hoque (25) S/O Yaiab Ali of Atia bari, PS- Sahebgang, Dist- Coochbehar is selling ID liquor illegally at his shop at NJP hotel line under PS- NJP, Dist- Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 828 dated 17.08.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/ 08 Laxman Roy, HG/794 Ranjit Roy all of NJP PS, SPC left for NJP hotel line under PS- NJP, Dist- Jalpaiguri to work out the information in hand. At about 18.45 hrs we arrived at NJP hotel line, PS- NJP, Dist- Jalpaiguri and being identified by the source I held raid at the hotel at NJP hotel line of the said accused and managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor at the shop located since long for his illegal gain. On search the above noted I/D liquor recovered from his hotel. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from his hotel. Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 18.55 hrs. to 19.20 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Rubel Hoque (25) S/O Yaiab Ali of Atia bari, PS- Sahebgang, Dist- Coochbehar and arrange for its investigation.
