That few people have been trying to occupy my land and in this regard they have also constructed a temporary structure of bamboo in front of my land and they are trying to block the entrance of my land. They have also put up a banner near the temporary shed in the name of Ekta Club. They showed immense hostility towards us and threatened us using slang language at me and have physically abused me. The photographs of some of these people which have been captured in the camera are attached to this FIR. There are others whose images are not available to us and hence have not been identified.

I request you to do the needful and save my land from illegal occupation.
