Sir,

With due respect, I, PSI-Pradeep Diyali presently attached with NJP PS under your kind control beg to state that today i.e. on 19.08.2022 at 2015 hrs I received a secret source information that one person namely Ajay Saha (40) yrs s/o Haran Ch. Saha of Ambikanagar, PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at his Hotel style as "Mama Bhagna Hotel" at Fulbari Bazar under PS- NJP, Dist.-Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 941 dated 19.08.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/08 Laxman Roy, HG/794 Ranjit Roy, CV/116 Rohit Kumar Mashato all of NJP PS, SPC left for Fulbari Bazar under PS-NJP, Dist.- Jalpaiguri to work out the information in hand. At about 2045 hrs we arrived at Fulbari Bazar at Hotel style as "Mama Bhagna Hotel", PS- NJP, Dist.- Jalpaiguri and being identified by the source I held raid at the hotel style as "Mama Bhagna Hotel" but the accused person namely Ajay Saha (40) yrs s/o Haran Ch. Saha of Ambikanagar, PS- NJP, Dist.- Jalpaiguri after seeing the Police Team fled away from his Hotel. On being search at the Hotel style as "Mama Bhagna Hotel" in presence of witness recovered i.11 (Eleven) bottles of Himalayan Gold 60 Country Spirit containing 600 ML in each bottle. ii. 07 (seven) bottle of Kingfisher Strong Premium Beer containing 650 ML in each bottle from his hotel style as "Mama Bhagna Hotel". Accordingly, in presence of witness I, seized the above noted /D liquor from the Hotel style as "Mama Bhagna Hotel" under proper seizure list. The whole process of search & seizure was made in between 2115 hrs to 2145 hrs

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the owner of the Hotel style as "Mama Bhagna Hotel" namely Ajay Saha (40) yrs s/o Haran Ch. Saha of Ambikanagar, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
