With due respect, I am producing herewith one arrested accused person namely Arjun Das (34) yrs s/o Mintu Das of Bajitpur, PO-Birghai, PS- Rajganj, Dist.- Uttar Dinajpur A/P Fulbari Bazar, PS- NJP, Dist.- Jalpaiguri under arrest and the following articles under seizure. The ground of arrest duly been communicated with him.

- I. 16 (Sixteen) bottles of Kingfisher Strong Premium Beer containing 650 ML in each Bottle.
- II. One white color Nylon Bag.

I, PSI-Newton Biswas presently attached with NJP PS under your kind control beg to state that today i.e. on 19.08.2022 at 2015 hrs I received a secret source information that one person namely Arjun Das (34) yrs s/o Mintu Das of Bajitpur, PO-Birghai, PS- Rajganj, Dist.- Uttar Dinajpur A/P Fulbari Bazar, PS- NJP, Dist.- Jalpaiguri is selling ID liquor illegally at Fulbari Bazar near road side under PS- NJP, Dist.-Jalpaiguri. Accordingly, I diarized the fact in the General diary vide NJP PS GDE No. 941 dated 19.08.2022 and informed the fact to you. As per your kind direction and instruction myself along with VP/ 13 Jamirul Islam, CV/306 Biswajit Roy all of NJP PS, SPC left for Fulbari Bazar under PS-NJP, Dist.- Jalpaiguri to work out the information in hand. At about 2055 hrs we arrived at Fulbari Bazar, PS- NJP, Dist.- Jalpaiguri and being identified by the source I found the said accused person selling Illegal Distilled liquor to his regular customer at Fulbari Bazar near road side, and as per the indication of source managed to apprehended him. During interrogation he disclosed his identity as noted above and also disclosed that he is selling ID liquor near road side at Fulbari Bazar since long for his illegal gain. On search the above noted I/D liquor recovered from his possession. On demand he failed to produce any documents/licence in respect of store/sale the I/D liquor recovered from the bag carrying by him Accordingly, I seized the above noted I/D liquor from his possession under proper seizure list and arrested him under proper memo of arrest and observing all the formalities of arrest. The whole process of search & seizure was made in between 2115 hrs to 2155 hrs.

Under the above noted fact and circumstances, I, therefore, pray before your kind honour that a specific case under proper section of law may kindly be started against the arrested accused namely Arjun Das (34) yrs s/o Mintu Das of Bajitpur, PO-Birghai, PS- Rajganj, Dist.- Uttar Dinajpur A/P Fulbari Bazar, PS- NJP, Dist.- Jalpaiguri and arrange for its investigation.
