With due respect I am producing herewith the arrested accused persons namely (i) Mithun Mandal (30) of Kashmir Colony, PS-NJP, Dist- Jalpaiguri, (ii) Sabab Ali (24) S/O Alajuddin of Tinbati Bazar, PS- NJP, Dist- Jalpaiguri (iii) Akash Hela (23) S/O Lt. Rajen hela of Nandigram, Joytrmoy Colony, PS- NJP, Dist- Jalpaiguri (iv) Adhir Sarkar (42) S/O Lt. Ananta Sarkar of Kashmir Colony, PS-NJP, Dist- Jalpaiguri (v) Md. Rabioul (24) S/O Farjan Hoque of Kalingani, P.S- NJP, Dist - Jalpaiguri, and (vi) Dipak Paswan (19) S/O Lt. Sikkandar Paswan of Jorpakhri, PS- NJP, Dist- Jalpaiguri, and the following articles under seizure :-

1. One iron made sharp cutting weapons called as Hasua and one torch light and one screw driver (approx 15 inch) from the possession of accused Mithun Mandal (30) S/O-Lt. Shyamchand Mandal of Kashmir Colony, PS-NJP, Dist- Jalpaiguri.
2. One iron made sharp cutting weapons called as Bhojoli from the possession of accused Sabab Ali (24) S/O Alajuddin of Tinbati Bazar, PS- NJP, Dist- Jalpaiguri.
3. One sharp cutting knife and one torch light from the possession of accused Akash Hela (23) S/O Lt. Rajen hela of Nandigram, Joytrmoy Colony, PS- NJP, Dist- Jalpaiguri.
4. One iron rod from the possession of accused Adhir Sarkar (42) S/O Lt. Ananta Sarkar of Kashmir Colony, PS-NJP, Dist- Jalpaiguri.
5. One sharp cutting knife and one torch light from the possession of accused Md. Rabioul (24) S/O Farjan Hoque of Kalingani, P.S- NJP, Dist - Jalpaiguri.
6. One iron made sharp cutting weapons called as Bhojoli from the possession of accused Dipak Paswan (19) S/O Lt. Sikkandar Paswan of Jorpakhri, PS- NJP, Dist- Jalpaiguri.

1. ASI Sajal Das of NJP PS, Siliguri Police Commissionerate beg to state that on 10/08/2022 at 01:25 hrs received a secret source information that a gang of miscreants come at near Gatebazar, PS- NJP, Dist- Jalpaiguri with deadly weapons and assembled there and making preparation for committing dacoity at Gatebazar area. Accordingly, I diaised the fact in General Diary vide NJP PS GDE No 446 dated 10/08/2022 and informed the fact to you as well as Asst Commissioner of Police, East -II, SPC about the information. I also informed the fact to night IT Van officer and requested them to come to Gatebazar to accompany with us. At 01:45 hrs we arrived at Gatebazar near Youbahharati Club under PS- NJP, Dist- Jalpaiguri and ambush there. At 01:55 hrs as indicated by the source we noticed that 11/12 persons assembled in a dark place near Gatebazar, PS- NJP, Dist- Jalpaiguri and they were whispering in a very low voice. Accordingly, we cordoned the place properly and approach towards them very slowly and carefully but seeing the police party they started to flee away but we the police party managed to apprehended 06 (six) of them with deadly weapons in their possession. On interrogation the apprehended accused persons disclosed their name and identity as noted above.

During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence in middle of the night with deadly weapons. Finally they disclosed that they assembled there for committing dacoity at Ambikagar area. Accordingly, I seized the above noted weapon of offence from their possession under proper secure list and arrested the above noted 06 (six) accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to NJP PS. The search seizure and arrest made in between 02:15 hrs to 02:35 hrs on 10/08/2022.

Under the above noted fact and circumstance, I therefore pray to you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Mithun Mandal (30) S/O Shyamchand Mandal of Kashmir Colony, PS-NJP, Dist- Jalpaiguri, (ii) Sabab Ali (24) S/O Alajuddin of Tinbati Bazar, PS- NJP, Dist- Jalpaiguri (iii) Akash Hela (23) S/O Lt. Rajen hela of Nandigram, Joytrmoy Colony, PS- NJP, Dist- Jalpaiguri (iv) Adhir Sarkar (42) S/O Lt. Ananta Sarkar of Kashmir Colony, PS-NJP, Dist- Jalpaiguri (v) Md. Rabioul (24) S/O Farjan Hoque of Kalingani, P.S- NJP, Dist- Jalpaiguri, and (vi) Dipak Paswan (19) S/O Lt. Sikkandar Paswan of Jorpakhri, PS- NJP, Dist- Jalpaiguri, and others and arrange for its investigation.
