SUBJECT - F.I.R. AGAINST MITHU MALLICK & HIS FAMILY

Respected Sir,

I, SMT. AROTI MALLICK, W/o. Mithu Mallick, D/o. Shambhu Mallick, R/o. NBU Gate No. 1, Subodhpally, P.S. Matigara, District Darjeeling, Pin-734011, West Bengal, INDIA would like to state that as follows:-

1. That I was married to according to MITHU MALLICK, son of Rajesh Mallick, R/o. NBU Gate No. 1, Subodhpally, P.S. Matigara, District Darjeeling according to Hindu rites & customs on 29.01.2016. After our marriage I gave birth to one (1) female child namely Megha Mallick aged about 4 years & 11 months.
2. That before birth of my child everything was good but soon after birth of child my husband started mental & physical torture upon me for demand of dowry. I was harassed and physically tortured by my husband, Father-In-Law namely Rajesh Mallick & Mother-In-Law namely Bina Mallick.
3. That my husband used to beat me every night for want of money & dowry and he was supported by his father & mother in this illegal demand. He always used to force me to call my parents and ask money from them and on my refusal to do so my husband used to beat me in front of my Father-In-Law & Mother-In-Law.
4. That six month earlier I came to know that my husband had relationship with one minor girl namely Manisha Bansfore of Railway Colony, Bagdogra. I tried my best to make him understand but my husband didn't pay any heed to my words. On the other hand he used to say that if I don't bring money from my

parents then he will leave me and my daughter and marry Manisha Bansfore of Railway Colony, Bagdogra and start residing with her. I informed the matter to my Father-In-Law & Mother-In-Law also but they always supported their son and put pressurised me to either bring money from my parents or leave the house.

5. That after knowing the relationship of my husband & Manisha Bansfore I called Manisha Bansfore and informed her that I am the wife of Mithu Mallick & I have a daughter from him and requested her to maintain distance from my husband. Then and there Manisha Bansfore informed my husband and my husband came home with one plastic drum which contained kerosene oil and tried to ablaze me. My husband pour the full kerosene oil on me but I anyhow came out of my house and saved myself.
6. That suddenly on 18-08-2022 at about 3.00 P.M. my husband left home without informing anything to me and later I came to know that he has fled away with on girl namely Manisha Bansfore of Railway Colony, Bagdogra.
7. That Manisha Bansfore knew very well that my husband is married and he had one daughter but after knowing the fact she fled away with my husband and they got married.

It is requested before you to kindly take necessary strict action against my husband, Father-In-Law, Mother-In-Law and Manisha Bansfore so that they can be punished for the illegal act and I and can get justice.
