With due respect, I am producing herewith 04 (four) arrested accused persons namely (i) Debasish Das (25 yrs) S/O Late Debu Das of Simultala, Baba Loknath Colony, PS- Matigara, Dist.- Darjeeling (ii) Naba Barman (24 yrs) S/O Late Ganapati Barman of Kala Bagan, Patiram Jote, PS- Matigara, Dist.- Darjeeling (iii) Prakash Kr Sha (28 yrs) S/O Raj Kr Sha of Biswas Colony, Matigara Rail Gate, PS- Matigara, Dist.- Darjeeling and (iv) Dibjal Seik (19 yrs) S/O Late Badsha Seik of Paribahan Nagar, Jhupri Patty, PS- Matigara, Dist.- Darjeeling and the following articles under seizure :-

1. One iron made sharp cutting weapon called as Bhojali recovered from the possession of accused Debasish Das S/O Late Debu Das of Simultala, Baba Loknath Colony, PS- Matigara, Dist.- Darjeeling.
2. One iron made sharp cutting knife, recovered from the possession of accused Naba Barman S/O Late Ganapati Barman of Kala Bagan, Patiram Jote, PS- Matigara, Dist.- Darjeeling.
3. One iron made sharp cutting knife and one torch light recovered from the possession of accused Prakash Kr Sha S/O Raj Kr Sha of Biswas Colony, Matigara Rail Gate, PS- Matigara, Dist.- Darjeeling.
3. One iron made sharp cutting weapon called as Hasua and one torch light recovered from the possession of accused Dibjal Seik S/O Late Badsha Seik of Paribahan Nagar, Jhupri Patty, PS- Matigara, Dist.- Darjeeling

I, SI Goutam Mallik of Matigara PS, Siliguri Police Commissionerate beg to state that on 22.08.22 at 01.25 hrs received a reliable secret source information that that a gang of miscreants come at near Terenga More, Patiram Jote under PS- Matigara, Dist.- Darjeeling with deadly weapons and assembled there and making preparation for committing dacoity at Patiram Jote area. Accordingly, I diarized the fact in General Diary vide Matigara PS GDE No 1139 dated 22.08.22 and informed the fact the Officer-In-Charge, Matigara PS, SPC and as per his kind order and direction I along with ASI Dharendra Nath Mandal C/ 974 Mintu Sen, C/1053 Paresh Rava, C/219 Sanatan Chitrakar, C/374 Debraj Biswas, CV-155 Sukumar Das and CV- 387 Sukumar Barman all of Matigara PS, SPC left for Terenga More, Patiram Jote under PS- Matigara, Dist.- Darjeeling to verify the veracity of said source input. I also informed the fact to Night RT Van officer ASI Laxman Saha of Matigara PS and directed him come to Terenga More, Patiram Jote to accompany with us. At 01.55 hrs we arrived at Terenga More, Patiram Jote under PS- Matigara, Dist.- Darjeeling. After a few time RT Van Officer ASI Laxman Saha along with force came to near Terenga More, Patiram Jote and accompany with us. At about 02.10 hrs as indicated by the source we noticed that 08/10 persons assembled in a dark place at near Terenga More School ground under PS- Matigara, Dist.- Darjeeling and they were whispering in a very low voice. Accordingly, we cordoned the place properly and very carefully and approach towards them very slowly and carefully but seeing the police party they started to flee away from the spot but we the police party after a hot chase managed to apprehended 04 (Four) of them with deadly weapons in their possession. On interrogation the apprehended accused persons disclosed their name and identity as noted above. During further interrogation they give different statement in different time and failed to give any satisfactory reply for their presence in middle of the night with deadly weapons. Finally they disclosed that they assembled there for committing dacoity in a house at Patiram Jote area. On search the above noted weapon of offence recovered from their possession. Accordingly, I seized the above noted weapon of offence from their possession under proper seizure list and arrested above noted 04 (Four) accused persons under proper memo of arrest and observing all the formalities of arrest and brought them to Matigara PS. The search seizure and arrest made on 22.08.22 in between 02.45 hrs and 03.35 hrs.

Under the above noted fact and circumstance, I, therefore pray to you that a specific case under proper section of law may kindly be started against the above noted 04 (four) arrested accused persons namely (i) Debasish Das (25 yrs) S/O Late Debu Das of Simultala, Baba Loknath Colony, PS- Matigara, Dist.- Darjeeling (ii) Naba Barman (24 yrs) S/O Late Ganapati Barman of Kala Bagan, Patiram Jote, PS- Matigara, Dist.- Darjeeling (iii) Prakash Kr Sha (28 yrs) S/O Raj Kr Sha of Biswas Colony, Matigara Rail Gate, PS- Matigara, Dist.- Darjeeling and (iv) Dibjal Seik (19 yrs) S/O Late Badsha Seik of Paribahan Nagar, Jhupri Patty, PS- Matigara, Dist.- Darjeeling and arrange for its investigation.
