
I, SI Upendra Nath Roy of Bagdogra PS, Siliguri Police Commissionerate, do hereby lodge written complaint, on producing one arrested accused person namely Raghunath Biswas (37) s/o Lt. Shanti Biswas of Rangapani PS Bagdogra Dist. Darjeeling under arrest along with following seized articles;

1. Thirty eight (38) sealed Bottles of Officers Choice Deluxe Whisky, each bottle 180 ml, Marked as exhibit-A in which 01 bottle taken as sample for examination exhibit-A1.
2. Fifteen (15) sealed Bottles of Mcdowells No. 1 celebration RUM, each bottle 180 ml, Marked as exhibit-B in which 01 bottle taken as sample for examination exhibit-B1
3. Eight (8) sealed Bottles of Imperial Blue classic grain whisky, each bottle 180 ml, Marked as exhibit-C in which 01 bottle taken as sample for examination exhibit-C1
4. Four (4) sealed Bottles of Imperial Blue Classic grain whisky, each bottle 375 ml, Marked as exhibit-D in which 01 bottle taken as sample for examination exhibit-D1
5. Twenty Five (25) sealed Bottles of Himalayan Gold Country spirit 60 up, each bottle 600 ml, Marked as exhibit-E in which 01 bottle taken as sample for examination exhibit-E1
6. Fourteen (14) sealed Bottles of Tuborg premium Beer, each bottle 650 ml, Marked as exhibit-F in which 01 bottle taken as sample for examination exhibit-F1
7. One Wagonr vehicle bearing No. WB-74-H-5319

I am submitting a written complaint against the above noted accused person to the effect that today 20.08.22 at 17-55 hrs received secrete source of information that two persons with one Wagonr vehicle was coming towards Rangapani Bazar from Ghoshpukur side with huge quantity of ID Liquor illegally for selling the same from their Hotel situated at Rangapani Bazar without any valid license. Accordingly the duty officer of Bagdogra PS informed the matter to O.C. Bagdogra PS and as per his instruction myself along with SI Binup Mahato, ASI Khangen Barman, C/1008 Kanak Roy, VP-02 Pradip Roy, CV- 389 Janak Singh, VP-01 Ansalam Kujur left for Ranidanga Bazar to verify the veracity of information which noted in GD vide Bagdogra PS GDE No. 959 dt. 20.08.22 and 18-45 hrs arrived at Rangapani Bazar by Govt. vehicle and started Naka checking duty. At about 19-35 hrs during Spl. Naka checking as well as on identified by the source we gave signal to stop one Wagonr vehicle, but on seeing police said vehicle try to flee away from there, on hot chase we somehow managed to detained the said Wagonr vehicle bearing No. WB-74-H-5319 with one person who was inside of that vehicle and one another person managed to flee away from the said vehicle at Rangapani. On being asked he disclosed his name and address noted above and also disclosed the name of the absconded person namely Sukhdeb Biswas who is brother of him. At the time of search and seizure when on called of local people to appear as witnesses, none of them came forward, hence in presence of police witnesses I searched the said vehicle and recovered huge quantity of ID Liqueure noted above from inside of the said vehicle which is seized by me as per proper seizure list and also seized the said Wagonr vehicle from the possession of the apprehended person and labelled duly signed by him and also witnesses. On being asked the apprehended person stated that they purchased the same from Ghoshpukur for the purpose of selling the same from his Hotel at Rangapani Bazar in order to earn huge money illegally to his customers of that area and failed to produce any document or license for carrying the liquor and confessed his guilt. As such I arrested the above noted accused person u/s 41 Cr.P.C. as it's a violation under Bengal Excise Act. This seizure & arrest was made in between 19-55 hrs and 21-35 hrs (seizure Total 36.5 Ltrs approx).

Therefore, I request you to start a specific case under proper section of law against the persons namely (1) Raghunath Biswas (37) and (2) Sukhdeb Biswas both s/o Lt. Shanti Biswas of Rangapani PS Bagdogra Dist. Darjeeling and arrange for its investigation.
