

With due respect in reference to the above noted I like to state that on 11.08.22 a written complaint was received from one Anu Lepcha, D/O Latshering Lepcha of Todey Bazar, Jaldhaka to the effect that on 03.08.22 she had gone to Champasari, Siliguri for Parlour Training at the parlour of one Digen Lepcha, S/O Donal Lepcha of Todey Pala, Jaldhaka. But on the night of 08.08.22 at about 23.00hrs Digen Lepcha entered the room of complainant Anu Lepcha and assaulted her with fists and kicks as a result suffered injury. Over this Jaldhaka P.S. Case no. "00/22" dtd. 11.08.22 u/s 457/354 IPC was recorded.

The P.O. is at the Champasari, P.S. Pradhan Nagar, Siliguri Police Commissionerate.

Therefore, I request before your kind honour that necessary order may kindly be passed and forward the Zero F.I.
