Sub: Request for lodging Zero F.I.R.

Sir,

With due respect, I have the honor to inform you that yesterday i.e. on 16th august 2022 at around 8:00 P.M, while I was returning from Siliguri to my Office Headquarter Berhampore, on the way to my rented house located at Pradhan Nagar, B.B.D Colony Ward No. 2, where my wife & son is residing due to education purposes. Than one **Chotka Das, S/o. Kanti Ranjan Das** working as a Civic Volunteer under dial 100 suddenly appeared before me and started to charging me upon a baseless topic that why I have passed urine in a drain in a very aggressive attitude as if he is working in Police Department. Sir as the nature call was very urgent & I have no option. I have tried my level best to make him understand but he did not heed. Later on, he assaulted me physically with lethal weapon as a result of which I received injuries on my face and under right eye. Medical report already done from Siliguri District Hospital in EMERGENCY

In this regard, I request you to kindly look into the aforementioned matter and **Register a case under ZERO F.I.R.** for taking further necessary action against the said accused person as per the law. Sir, this person who is not even a permanent employee of the said department and whose attitude is so rough that instead of look after law and order around the society is just opposite. This kind of person maybe dangerous in the coming future if his service got permanent and a bad name in the Police Department.
