SUB: First Information Report

Sir,

With due respect, I am producing herewith seized one tractor bearing reg no. WB 73 F/9468 loaded with sands (River bed materials)

I ASI Manoj Kumar Roy of Pradhannagar Ps under Siliguri Police Commissionerate do hereby lodge this complaint to the effect that today on 22.08.2022 at about 07.05 hrs while myself along with C/836. Sangmit Chettri and CV- 649 Pancham Singha were performing mobile van duty near Devidanga area vide Pradhannagar Ps GDE no. 1345, Dt. 21.08.2022 at that time received a source information that a tractor bearing registration no. WB 73 F/ 9468 loaded with river bed materials was coming from Middle Palash side in order to clandestinely dispose the same to his customers. As such myself along with force left for Middle Palash to verify the veracity of the information. After reaching at Middle Palash I found that one tractor bearing registration no. WB 73 F/ 9468 was coming from Mahananda river towards Devidanga. I tried to stop the said tractor but the vehicle of driver did not stop the Tractor. After hot chased, I managed to apprehend the said Tractor but the driver of vehicle fled away leaving his Tractor. Then I reached the said Tractor and found that the Tractor loaded with sand (river bed materials). It is evident that the driver of the said Tractor was stolen the sand from Mahananda river bed and carrying of said Mines & Minerals articles without any valid document for their wrongful gain. Then I seized the Tractor and also prepared a seizure list duly signed by the witnesses.

Therefore, I pray before you that a specific case under proper section of law may kindly be Initiated against the owner and driver of the vehicle having registration no. WB 73 F/9468 and arrange for its investigation.
