After expiry of my husband I was shocked for a year and the suddenly I was meet up with Kanai Routh but he meet with me as Amit Das but it was his duplicate name. From that moment he saw me, he used to judge me and wanted to meet me and wanted to know exactly where is my house and where I am living, and one day he reached to my In-laws house.

That on 2008 finally reached to my father-in-law and mother in laws house to approach to Marry with meand my in-laws thought that since that time our daughter in laws awidow so it would be better to marrywith someone.

After some time when my father-in-laws Said to the Person that alright then you marry to her, then after that the Person Started toignoring me and also in my in-laws.

After that he said we can continue our relationship like other days to be a Interest any between us, and he said i don't know bengali language and i don't understand and then isaid to him many times to take me your house but he always ignoring me and refused my proposal. It was a little bit worried me but I was thought thatI have in relationship with him and I am alone then forgate everything.

After that Kanai Routh got marry me in a ordinary temple and to give me vermilion in the Year of 2010. Then he again marry me Dakshineswar Kali Mandir at Kolkata in the year 2017 to Win my faith.

Then I Came to know on 2018 that he has two daughter and he already married to another woman, I was shocked and devastated, then he started to explaining me a lot of excuse. Then he meet my sister on 2019 and promise that he would take good Care of me and lived happy and peacefully.

I got pregnant on 2017 during Intercourse and both time I was medicated and my baby was ruined forcefully.

Currently I am being severally harassed from his house and he is harassing me by different people through phone calls and threatening to kill me and Coming to my Siliguri's house humiliating me in front of everyone. I am alone and nobody in my house as guardian. So I am very scared. After that when i come to know these things, when I asked him again and again then he kept threatning me they would kill me or they would buy all the lawyers and police and administration. Because they have lot of money.

I have enough Call recording and proofs of the applications he cheated on me.

Thus I am cheated by him and now i approach to the law and I have full faith and hope in the Law with fully cooperate with me.

I will be forever benefited by the Law if the said Culprit is caught and Punished as soon as possible.


So I therefore requested you to look into the matter and do Investigate the same and also to take necessary legal action against the said Kanai Routh alias Amit Das and for this act of kindness i shall much oblige.
