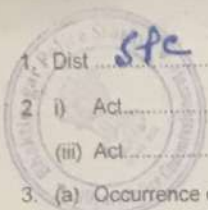

Sir,

I SI Rantu Haldar S/O- Monoranjan Haldar of Bhaktinagar Police Station, Siliguri Police Commissionerate after producing two accused persons namely (1) Nirmal Sharma-35yrs s/o Gopal Sharma of 8th Mile, Kalimpong PS Kalimpong Dist Kalimpong and (2) Krijan Chhetri-19yrs s/o Krishna Bahadur Chhetri of Salugara, BSF Road, PS Bhaktinagar Dist Jalpaiguri along with seizure articles total (1) 18 strips of Winspasmoforte capsules and each strips containing 08 Pieces total 18X8=144 Pieces which composition with Tramadol hydrochloride-1P 50 mg Acetaminophen 1P 325mg & Dicyclomine Hydrochloride 1P 10mg (2) 20 (Twenty) Vials of DIAZEPAM INJECTION each vial containing 02 ML (3) 20(Twenty) Vials of PHENERGAN INJECTION each vial containing 02 ML (4) 20 (Twenty)Vials LUPIGESIC INJECTION each vial containing 02 ML contained in a Black and blue colour school bag and (5) One Blue colour R15 Motor cycle having Registration No-WB74BE/2596 do hereby lodged written complaint to the effect that on 22.08.22 at 19.15 hrs received reliable source information that two persons were standing Near Senco Gold shop opposite Suchitra Hotel under Bhaktinagar PS with a blue colour motor cycle to deliver the same to someone. It is reasonably believe that the persons possessing the bag containing Injection & capsules may escape from the scene if Police party did not reach the spot immediately. The information was reduced in writing vide Bhaktinagar Police Station GDE no. 1480 dated 22.08.22 and informed superiors about the plan of action. Thereafter myself along with SI Sajal Roy, SI Srimanta Chatterjee, ASI Dipak Karmakar, C/1430 Dilip Barman, CVF/935 Biplob Roy, CVF/014 Labonmoy Barman taking blank paper, wax, metal seal and knife and other kits left for Near Senco Gold shop opposite Suchitra Hotel to work out the information vide Bhaktinagar PS GDE No-1481 dated 22.08.22 & MCC No- 911/22 dated 22.08.22.

At 19.40 hours I along with officer and force reached near Near Senco Gold shop opposite Gully of Suchitra Hotel, Sevoke road and contacted the source who show us the persons with the blue colour school bag one Motor cycle suspected to be contained capsules & injection from a certain distance, I briefed all Officers and force to cordon the persons as tactful as possible in order to thwart their escape from the scene. Meanwhile I called two independent witnesses namely 1) Bikash Das-23yrs s/o Lal bihari Das of South Baghajatin Colony, PS Pradhannagar Dist Darjeeling and (2) Bobby Roy-22yrs s/o Jitu Roy South Baghajatin colony PS Pradhannagar Dist Darjeeling after apprising them about the information received requested them in written to remain present with us during search and seizure and also called one Videographer namely Netai Chowdhury of Shivarampally, PS Bhaktinagar Dist Jalpaiguri with a request to record the whole process. We rounded him up and questioned about their name and address when they disclosed their identity as above. On interrogation about the bag possessing by them, initially did not disclose anything about contains of bag. I forced him to open it, when they disclosed that the bag contains injections & capsules belong to them. On further interrogation they disclosed that they procured the illegal capsules & injections from Siliguri to deliver the same to another person. Then I detained them and gave an option in writing whether they are willing to be searched in presence of an Executive Magistrate or Gazette Police Officer, on return they given written reply that they are willing to be searched in presence of Gazette Police Officer. Then I informed Shri Gyalnsen Lepcha, Assistant Commissioner of Police, (Traffic) SPC as Special Executive Magistrate to come near Near Senco Gold shop opposite Gully Suchitra Hotel, requested him to presence during search and seizure of the injections & capsules.

At 20.30 hrs Shri Gyalnsen Lepcha, Assistant Commissioner of Police, arrived at spot. Thereafter I opened the bag and found illegal injections & capsules inside. I asked the accused persons above named to produce document if any in support of possessing such a huge quantity of injections & capsules also motor cycle with them but they failed to produce any document. I seized the following articles under proper seizure list in presence of witness under direct supervision of Shri Gyalnsen Lepcha, Assistant Commissioner of Police, (Traffic) SPC under proper labeling.

NATURE OF ARTICLES SEIZED

- 1) 18 (Eighteen) strips of Winspasm-Forte capsules and each strips containing 08 Pieces total 18X8=144 Pieces (Total 84.64grams) which composition with Tramadol hydrochloride-1P 50 mg Acetaminophen 1P 325mg & Dicyclomine Hydrochloride 1P 10mg Marked as **EXHIBIT-A** out one strip (08pcs) taken as sample marked as **Exhibit-A1**
- 2) 20 (Twenty) Vials of DIAZEPAM INJECTION (Total weight 85.6 grams) composition with Diazepam 1P 5 mg, each vial containing 02 ML marked as **Exhibit-B** out of 01 vials taken as sample marked as **Exhibit-B1**
- 3) 20 (Twenty)Vials of PHENERGAN INJECTION (Total weight 80 grams) which composition with hydrochloride-1P 25mg, each vial containing 02 ML marked as **Exhibit-C** out of 01 vials taken as sample marked as **Exhibit-C1**
- 4) 20 (Twenty) Vials LUPIGESIC INJECTION (Total weight 82.8 grams) composition with Buprenorphine hydrochloride-1P equivalent to Buprenorphine 0.3Mg each vial containing 02 ML marked as Exhibit-D out of 01 vials taken as sample marked as **Exhibit-D1**
- 5) One Blue and Black colour school bag marked as **Exhibit -E** on which Exhibit-A,B,C,D were kept.
- 6) One Blue colour R15 Motor cycle having Registration No-WB74BE/2596 and marked as **Exhibit -F**

(Seizure was made in between on 22.08.22 in between 21.15 hrs to 22.55 hrs)

Under the above circumstances it is evident that the accused persons above named procured has committing offence under NDPS act. On interrogation accused persons confessed them guilt and stated that they were doing such kind of business illegally with any valid documents/License since long for their wrongful gain. It is crystal clear that the accused persons are peddling prescription drugs meant for the sick people to cater to the need of drugs abusers in the locality illegally which has become menace to the life of the young generation and perishing the home of thousand parents. All the seized contents Psychotropic substance and falls under NDPS act. I arrested them u/s 41 Cr.P.C. after explaining them about the ground of arrest issuing proper memo of arrest. Arrested accused persons along with seized articles brought to PS, seizure list and seized articles handed over to Malkhana dealing Officer under intimation to I.C. PS for keeping record in PS property register.

I therefore pray that a specific case u/s Narcotic Drugs and Psychotropic Substances Act 1985 may kindly be started against the accused persons namely (1) Nirmal Sharma-35yrs s/o Gopal Sharma of 8th Mile, Kalimpong PS Kalimpong Dist Kalimpong and (2) Krijan Chhetri-19yrs s/o Krishna Bahadur Chhetri of Salugara, BSF Road, PS Bhaktinagar Dist Jalpaiguri and arrange for its investigation.
