**Sub: Complaint against my husband 1) Deep Sutradhar, Son of Dulal Sutradhar, 2) my Father in law, Dulal Sutradhar, S/o Not Known and my mother-in-law, Reena Sutradhar, all are resident of North Samar Nagar, P.O- Salugara, P.S- Bhaktinagar, Dist Jalpaiguri**

Respected Sir,

I, **Smt. Ratna Roy Sutradhar**, Wife of Sri Deep Sutradhar and daughter of Dulal Roy, presently residing at Bhupendra Nagar, ward no. 42 of SMC, P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri, do hereby lodge a complaint against my husband 1) Deep Sutradhar, Son of Dulal Sutradhar, 2) my Father in law, Dulal Sutradhar S/o Not Known and my mother in law, Reena Sutradhar, all are resident of North Samar Nagar, P.O- Salugara, P.S- Bhaktinagar, Dist\_ Jalpaiguri, to the effect as follows:-

- 1) That my marriage was solemnized on 25/01/2016 with said Deep Sutradhar according to the Hindu rites, rituals and customs at my parental home i.e., at Bhupendra Nagar, ward no. 42 of SMC, P.O. Salugara, P.S. Bhaktinagar, Dist. Jalpaiguri.
- 2) That in the aforesaid marriage, my parents and my relatives gave cash of Rs.60,000/-, wooden box bed, steel showcase, T.V -22 inches of Univision company, Plywood dressing table, plywood bed, Gas Oven and two cylinder of Bharat Gas company, Scooty- Activa-125cc, Utensils etc., on the demand of my husband and in-laws as Stridhan Property. But they were not satisfied with the aforesaid cash, furniture, articles and things.
- 3) That out of the said wed-lock, I gave birth to a female baby namely Ananya Sutradhar on 13-11-2016 and presently she is aged about 6 years and studying in Class K.G at Sharda Sishutirtha High School. But it is pertinent to mention here that when my aforesaid baby was in my womb , my husband and in-laws put tremendous pressure upon me to abort the said baby but I denied to do the same then they use to abuse me in filthy languages and also mentally and physically tortured me.
- 4) That my husband and in-laws use to torture upon me mentally and physically frequently on trivial mistake in household works and use to pick up quarrel with me without any rhymes and reasons now and then.
- 5) That in the month of April, 2017 my mother in law threw hot mustard oil on my right arm.

- 6) That my husband and in laws on several occasions used to threatened me to leave my matrimonial home now and then else to face dire consequences.
- 7) That it is not out of place to mention here that my husband used to consume Alcohol regularly and use to abuse me in filthy languages and used to torture me physically and mentally regularly and unfortunately my in-laws used to instigate and incite to kill me.
- 8) That my husband and in-laws forcefully stopped me to keep any relation with my parents else to face untoward incident.
- 9) That on 10-08-2022 after taking permission and consent of my husband and in-laws, I along with my minor daughter came to my parental home on the eve of Rakhi Purnima and returned on 21-08-2022 but my husband and in-laws did not allow us to enter in to my matrimonial home and started abusing me in filthy languages. My husband pushed me forcefully and threw me outside the house and assaulted me physically but I was determined not to leave my matrimonial home at any circumstances, so I along with my daughter sat beside my matrimonial home and about 12 p.m. my husband due to the incitement of my in-laws forcefully took me and my child at a lonely place near Bartolla and left us alone but somehow I along with my daughter came near my matrimonial home and I was compel to call my parents and relatives over mobile phone and they came there but seeing my parents and relatives, they became angry and abused them in most filthy languages and physically assaulted my maami and bite by teeth to one of my relative but somehow my parents and relatives brought me and my child to my parental home at about 1:00 am.
- 10) That my husband and in-laws use to demand one two wheeler from my parents but when my parents denied them for the same, they used to torture me mentally and physically.
- 11) That my original Voter Identity card, Aadhar card, S/C Certificate, Bank passbook and LPG gas book and my minor daughter's original ration card Birth Certificate and Aadhar card are in the possession on my husband and in-laws

So, therefore, I humbly request you to take necessary legal action against my husband and in laws and booked them under specific provision of law at an earliest.
