Sir,

With due respect and in producing herewith the arrested accused person namely Piyasmit Mandal (26), S/O Lt. Subash Mandal of Rananagar, PS-Matigara, Dist- Darjeeling with following seized articles -

- > One vehicle bearing Reg. No. WB 73 F 2285 loaded with River bed materials.

In this regard, I PSI Arun Roy of Matigara P.S, SPC do hereby lodge this Complaint against above noted arrested accused person to the effect that on 22.08.2022 at about 14:05 hrs onwards I received a source information that one vehicle bearing Reg. No. WB 73 F 2285 loaded with River bed materials coming from Patiramjote side without any valid documents. Accordingly I inform the fact to Officer in charge, Matigara PS and as per his kind direction myself along with force had been to Patiramjote under PS Matigara to work out the information in hand. After arrival of the spot I found said vehicle bearing Reg. No. WB 73 F 2285 loaded with River bed materials standing at Matichaya, Patiramjote under Matigara PS area. Accordingly, I apprehended the driver of the vehicle. On demand he failed to produce any valid documents in respect of river bed materials loaded in his vehicle. On further interrogation, he stated that he mines such river bed materials from Patiramjote by illegal means with a view to sell the same for his illegal gain. Accordingly, I seized the above named vehicle loaded with illegally mined river bed materials under proper seizure list and arrested him after maintaining all formalities regarding arrest.

Therefore, I pray before you that a specific case under proper section of law may kindly be started against the arrested accused person namely Piyasmit Mandal (26), S/O Lt. Subash Mandal of Rananagar, PS-Matigara, Dist- Darjeeling or the owner of the vehicle and arrange for its investigation.
