Sir,

With due respect and in producing herewith 02 (two) arrested accused persons namely (i) Mantu Barman (28 yrs) S/O Prafullya Barman of Patan Fulbari Busty, PS- Matigara, Dist.- Darjeeling (Driver of vehicle No WB/73/E/9356) and (ii) Chiku @ Ajay Singha (38 yrs) S/O Late Bhutia Singha of Kheriya, Patan Fulbari Busty, PS- Matigara, Dist.- Darjeeling (Co-driver of vehicle No WB/73/E/ 9356) with following seized articles under proper seizure list :-

- 1) One vehicle (Tractor) bearing Reg. No. WB/73/E /9356 loaded with illegal River bed materials.

I, ASI Tapan Das of Matigara P.S, SPC do hereby lodge this Complaint against above noted 02 (two) arrested accused persons to the effect that on 22.08.22 at 17.45 hrs I received a secret source information that one vehicle (Tractor) bearing Reg. No. WB/73/E /9356 van loaded with River bed materials standing at Balasan River Bed, Fulbari Patan ghat without any valid documents. Accordingly, diarized the fact in General Diary vide Matigara PS GDE No 1186 dated 22.08.22 and informed the fact to the Officer-In-Charge, Matigara PS and as per his kind order and direction myself along with force had been Fulbari Patan to work out the information in hand. After arrival at Fulbari Patan we noticed that the above noted vehicle was coming from Fulbari Patan Ghat. We managed to detained the said vehicle displaying number plate WB/73/E /9356 loaded with illegal River bed materials and also managed to apprehended the driver and co driver as noted above of the said vehicle. On demand they failed to produce any valid documents in respect of river bed materials leaded in their vehicle. On further interrogation they stated that they mines such river bed materials from Balason river, Fulbari Patan Ghat by illegal means with a view to sell the same for their illegal gain. Accordingly, I seized the above noted vehicle leaded with illegally mining river bed materials under proper seizure list and arrested them after maintaining all formalities regarding arrest.

Therefore, I pray before you that a specific case under proper section of law may kindly be started against the arrested accused persons namely (i) Mantu Barman (28 yrs) S/O Prafullya Barman of Patan Fulbari Busty, PS- Matigara, Dist.- Darjeeling and (ii) Chiku @ Ajay Singha (38 yrs) S/O Late Bhutia Singha of Kheriya, Patan Fulbari Busty, PS- Matigara, Dist.- Darjeeling and arrange for its investigation.
